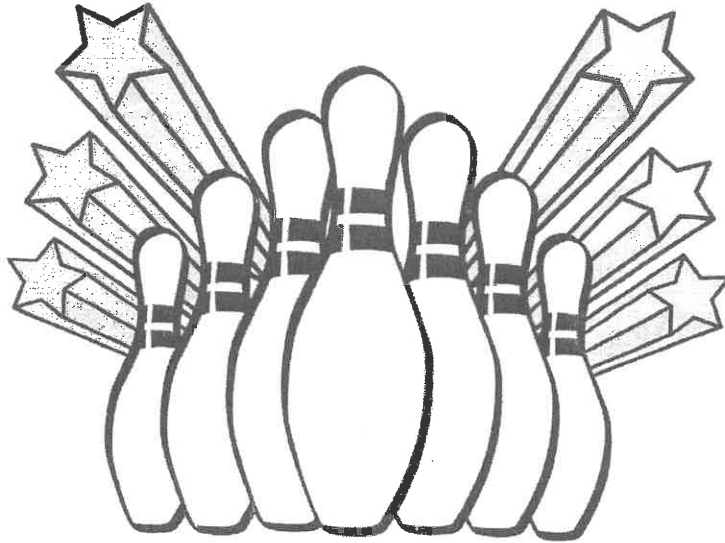

(2019) BOWLING TOURNAMENT RULES

APRIL 1, 2019 THROUGH JUNE 5, 2019

1. ALL BOWLERS MUST BE MEMBERS IN GOOD STANDING OF THE NATIVE DAUGHTERS OF THE GOLDEN WEST.
2. BOWLING EVENT WILL BE TEAM (FOUR MEMBERS) AND ONE CLASSIFICATION ONLY.
3. ALL SCORES WILL INCLUDE A HANDICAP OF EIGHTY PERCENT OF 200 PER BOWLER.
4. BOWLERS SHALL USE THEIR CURRENT LEAGUE AVERAGE. IF A BOWLER DOES NOT HAVE A CURRENT LEAGUE AVERAGE, SHE WILL USE HER AVERAGE FROM PRIOR NDGW TOURNAMENT. IF THIS IS THE FIRST TIME IN THE TOURNAMENT, AND SHE DOES NOT HAVE A LEAGUE AVERAGE, THE HANDICAP WILL BE COMPUTED USING THE AVERAGE OF THE FIRST THREE GAMES BOWLED.
5. IF A BOWLER FAILS TO SHOW AND NO REPLACEMENT CAN BE FOUND, HER TEAM WILL BOWL WITH A 120 AVERAGE BLIND SCORE.
6. ANY BOWLER USING A FALSE AVERAGE SHALL BE DISQUALIFIED AND FORFEIT ALL FEES.
7. EACH TEAM BOWLER SHALL BE RESPONSIBLE FOR BOWLING AND SENDING ENTRIES WITH VERIFIED SCORES TO THE BOWLING STATE CHAIRMAN NO LATER THAN JUNE 12, 2019. VERIFIED SCORES WILL BE COPIES OF BOWLING SCORES FROM THE BOWLING ESTABLISHMENT.
8. ALL PRIZES WILL BE AWARDED AT GRAND PARLOR ANNUAL MEETING.
