More than 150 Native Sons and Daughters from all across our golden state gathered together to Celebrate Admission Day – California’s 168th Birthday at South San Francisco’s Basque Cultural Center. Everyone enjoyed a fine meal and eagerly took part in a silent auction and raffle of prizes of all types including next year Giants-Dodgers tickets and a lot of amazing SF Giants memorabilia signed by many players including Willie Mays. Several Grand Officers and Past Grand Presidents from both Orders attended making the event even more special. The event raised funds for the historical preservation of both Orders and we were elated to celebrate California Admission Day in San Francisco. Honorary Co-Hosts of the event, NDGW Grand President Karen H. Fini and NSGW Grand President Carey D. Pearce ensured the entire afternoon was a wonderful success.

Ortega Adobe In San Buenaventura Honored by Poinsettia Parlor No. 318

When you see or hear the name Ortega, do you think of the canned "green chilies" you see in the grocery stores? Is there a California connection to this produce? Well, the answer is "YES. AND, WHAT IS THE NATIVE DAUGHTER CONNECTION?"

For over 30 years, two to three members have gone once a month and cleaned the adobe which was built in the 1857. Emigdio Ortega purchased the property from a Native American Indian from the Chumash Tribe. Initial titles for the roof, were from the San Buenaventura Mission. The adobe was larger when it was initially built but due to the flooding of the Ventura River in the Winter of 1866-67, the west half was destroyed.

So exactly what does Poinsettia Parlor No. 318 do each month? It entails swiping the dirt floors and watering them down. There's the dusting of furniture, vases, and other items. Any cloth items that need washing, pictures and glass items that need repair or replacing, identifying the people who have their pictures hanging in the adobe, and the planting of new plants, especially the CALIFORNIA POPPY (our official State flower) is accomplished.

The Members that have done this work are: Bonnie Clark, Shirley Clark, Jeanee Grist, Beverly Henry, Jackie Kelly, Corinne Klock, Marian Tulos, and currently Dolly Attaway, Mary Ann Foushee, and Evelyn Rowden. What is important is that Dolly Attaway's mother was married to an Ortega. Her coming to the Ortega each month is a "labor of love."

On Sunday, September 9th, we held an open house event at the Ortega. Ernie and Rosey Calvillo, who join us in the monthly cleaning, presented a program on the history of the Ortega and Emigdio Ortega's life dedication to this property. Over 80 members of the community, including officials of San Buenaventura, joined in the celebration.

We also work with the City of San Buenaventura Parks/Recreation & Community Partnership Department in accomplishing this "HISTORICAL ENDEAVOR OF LOVE." It's an ongoing process and true love of saving an historical site.

In addition, the Ventura County Museum also assisted us in obtaining information about the adobe and the historical family.



(NOTE: As stated above, this family started the ORTEGA GREEN CHILI COMPANY. They produced the product until the 1920's, when it became too large an operation to handle the local processing. It was moved to the Los Angeles area.)

Dear Sisters,

Well I was AMAZED... I did a search on the web for "easy ways to help the environment" and found lots of sites with oodles of ideas. Guess we need to be careful what we ask for. There were quite a few ideas that seemed to take little effort and that's just my speed. Easy as 1...2...3...4! Thought you might find these interesting too.

1. **Lint bunnies:** you know those balls of lint from your dryer, well guess how much \$\$ you could save if you clean the dryer's lint filter before each load? Maybe up to \$135 a year!! A dirty lint filter can use 30% more energy to get the job done.
2. **Drive smarter:** driving 60 miles per hour instead of 70 miles per hour can save up to 4 miles per gallon. Accelerating and braking too hard can actually reduce your fuel economy; so, take it easy on the gas and brake pedal.
3. **Time's up:** what do expiration dates on food products actually mean? Expiration dates actually refer to the product's quality, not safety and there's a difference between "sell-by" (the deadline for retailers to sell the product) and "use-by" (the date when the product starts to lose quality and flavor). To extend the "shelf life" of everything, keep the refrigerator at 40°F or lower and the freezer at 0°F. Store meats on the lower shelves where its coolest and unpack groceries as soon as you get home from



the store, if you have a long drive or its really hot, put frozen foods and meats in an ice chest or cooler bag. Another idea: shop for frozen foods, produce and meats toward the end of your shopping trip so they stay cooler. The average family throws away up to \$2200/300 lbs of food every year.

4. **What about batteries?** What can you do with dead AAA, AA, C & D alkaline batteries? They don't belong in the trash, they're toxic! To recycle them check out this website www.ehso.com (Environment, Health and Safety Online), this website has lots of good information. In California, both Lowe's and Home Depot will accept used batteries for recycling.

We hope you'll share any "green ideas" that you have. We're hoping to have a table at GPAM 2019 to showcase how our Parlors help the environment. 




