Attendance was just under 100 and included Peter Taylor, Mayor of Plymouth, Brian Oneta, Amador County Supervisor 5th District, Deacon Ed Pogue, parishioners, NDGW Grand Officers, Deputy Grand Presidents, and Parlor members from every part of California.

Boy Scout Troop 63 of Amador County lead the crowd in the pledge of allegiance followed by a beautiful rendition of the Star Spangled banner sang by Linda Sanchez. Elsin Dean, Forrest Parlor member and 1983 fundraising chair for the church expansion gave a wonderful talk about the support of the community who helped fund the project.

The plaque has a permanent place on the Eastern wall opposite of the front door. It reads: "First built in 1882 as a wooden building it was replaced by a Lath and Plaster building in 1939 after a fire. The growing congregation was accommodated with fund raising activities by members of the church. In 1983 the building expansion was accomplished by dividing the building and moving the west half further west as the center was filled in."

The staff was very grateful and most appreciative. As always, it is such an honor to be able to do something that supports our Veterans.

# Hidden California Jewel...

Just when we think we have seen “everything” in California, something comes up to remind us that California is full of “hidden jewels” and sometimes they are in our back yard!

That is what happened as we approached the “Dominguez Rancho Adobe” in Rancho Dominguez, an area that is part of the City of Compton, in the south west area of Los Angeles County.

Tucked away in an area of commercial buildings, stands this magnificent Rancho, on land that was part of “Rancho San Pedro”, the site of the first Spanish land grant in California, which encompassed 75,000 acres and included the entire Los Angeles harbor.

In 1967, it was decided to sell a large portion of the land, which proved to be the largest sale of land in southern California History. Part of the land was purchased by the state of California, and in 1965 the Board of Trustees of the California State Colleges voted to build a new campus, which eventually became “California State University Dominguez Hills”. In 2015 approximately 15,000 undergraduates and graduate students, with the nickname of “Toros” with the colors of “Toro Red and Gold” attended this college, which sits on land granted by Spain to our glorious California!

What brought us, the Native Daughters of the Golden West to this beautiful, serene spot on a beautiful Sunday afternoon, October the 9th, 2016? It was a wind mill. Yes, a windmill. In 1977, Wilmington Parlor No. 278, dedicated a historic marker to commemorate the first water well and windmill in the Rancho Dominguez area. The Dominguez Homestead Water Windmill fell into disrepair, and was all but lost. But under the guidance of the Dominguez Rancho Adobe Museum, it was lovingly restored. One of the men responsible for the restoring of the windmill found the small historical plaque, and approached Kathleen Rabago “Dona Maria Dominguez”, a member of Placerita Parlor No. 277 of what should be done with the plaque, and her reply was: “Whatever you do, DO NOT DO ANYTHING

WITH IT UNTIL I CONTACT THE NATIVE DAUGHTERS OF THE GOLDEN WEST!” After discussing this at a Parlor meeting, and as Wilmington Parlor was no longer in existence, Placerita Parlor voted to take on the responsibility to re-dedicate the windmill, not



in their name, but in the name of the Order of the Native Daughters of the Golden West, and place the plaque on the original position on the windmill to remind visitors of this important windmill, which brought water and power to the homestead and the area which surrounded it.

Our gratitude to Placerita Parlor No. 277,

under the direction of Past Grand President Beth Perrin, “Dona Maria Dominguez” and members of the Dominguez Rancho Adobe Museum, for allowing our Grand President Sherry Farley the privilege of heading the re-dedication team, and bringing us to this beautiful Rancho and surrounding area, a true “Hidden California Jewel”.



The Claretian Missionaries were deeded seventeen acres of the Rancho, upon which was built a beautiful compound used as a graduate school and later as seminary. It is still in use today, used as a retirement home for the Roman Catholic Priests of the Claretian Missionaries.

# In Loving Memory Past Grand President Nancy Brown March 18, 1946 – August 29, 2016

It is with great sadness that we advise you of the death of Past Grand President Nancy Elizabeth Brown on Monday, August 29, 2016 after a lengthy battle with cancer.

Born and raised in El Cerrito, she was the only child of Florence and Harry Giudici. Growing up, she played accordion and enjoyed visiting family. She graduated from El Cerrito High School and attended IBM Business School graduating with a B.A. in Business. Upon completion of her studies, she worked in multiple fields finally retiring after many years of service from the I.R.S. as a Liaison Officer for the Taxpayer Advocate Office.

Nancy was introduced to the love of her life, Bill Brown, by her cousin Paulette Moskwa, whom Nancy sometimes referred to as "her sister." On May 23, 1970 they were married and recently celebrated their 46th wedding anniversary. Bill and Nancy had two children, Diana and Matthew.

Nancy joined Argonaut Junior Unit No. 3 on December 12, 1961 and began her long journey through the Native Daughters of the Golden West. Upon reaching the age limit for Junior membership, her Advisors PGP Irma Caton and Claudia Evans sponsored her to join Argonaut Parlor No. 166. She was initiated on February 25, 1965. She advanced through the Parlor chairs, became a Deputy Grand President and Supervising District Deputy Grand President. She was

elected as Grand Trustee at the 1991 Grand Parlor in Santa Cruz and installed as Grand President in June 1997 in Modesto. Her theme was "California Dreaming". She presided over the 1998 Grand Parlor at the Sheraton Hotel in Concord with a 1950's theme complete with the Stalder's Corvette, poodle skirts, hula hoops, and an Elvis impersonator at her banquet.

Nancy loved people and conversation. Both before and after she was Grand President, she would travel to official visits and luncheons to support the many projects sponsored by our Parlors. She served as State Chairman of Mission Restoration, a project she deeply enjoyed. When she and Bill retired they moved from their home in Pinole to Live Oak where she immediately

became involved with the local Parlors and Sisters. She had a deep support of Past Presidents Association and attended their annual Assembly each year. She recently served as SDDGP in District 7 and a Deputy to Placer Parlor No. 138, Lincoln.

She is survived by her husband Bill, son Matthew and his wife Amy, cousin Paulette, as well as her Aunt who lives in Magalia.

## Paul Bunyan Days and Fort Bragg Parlor No. 210

Many of you have heard of the histories of the California forests. For many years, loggers cut down trees to help not only feed their families, but shape America into what it is now. Here in Mendocino County, we have a rich history associated with our trees and the loggers as well. The symbol for logging is the tale of Paul Bunyan and his blue ox, Babe. Every year since 1939 in Fort Bragg we celebrate those by gone times with Paul Bunyan Days, A Lumber Jack's Rowdy Good Time!

There are many events going on all over town. A logging show takes over the field by College of the Redwoods and there is a craft show at CV Star Center. Events for kids include a kiddie parade and games. Dogs are judged at the Ugly Dog Contest, there is a hot dog eating contest, old time dress revue, and pretty much something for everyone. Each year, the Native Daughters of the Golden West have participated, sometimes with elaborate floats in the parade, and other events. In the last few years, the Parlor has kicked off the weekend with a "Walk with Paul" on Friday afternoon. We have taken groups of walkers into the Otis Johnson Park to learn about the old growth redwoods and about the recent refurbishment of the park within the city. Last year's event was to take the public onto the yet unopened south trail on the mill property. That was our best attended walk with over 100 participating.

This year we elected to lead Paul and a group

of walkers through downtown Fort Bragg following the route outlined in a brochure we published in 2010. The brochure, "Street Corners of Fort Bragg" is out of print now, but we would like to reprint it. The walk took us down Main Street starting at the Guest House Museum built in 1892. Member Betty Carr gave an informative talk on the beginnings of Fort Bragg and how it formed around the C. R. Johnson mill site starting in 1884 when Mr. Johnson chose the property that had been a U.S. Army Post, built here in 1857 to settle conflicts with Indians on the Mendocino Indian Reservation. Member Edith Goble lead us over to the Company Store building where she had worked for 45 years. She spoke of the construction of the building and how things were in the 1950's and 60's. Member Marilyn Leroy lead us down Main Street talking of various buildings and their past uses including The Restaurant which was once a Hospital as was the Gray Whale Inn which is now a Bed and Breakfast. On the corner of Pine and Franklin we came to the First Baptist Church. It sports a bell that was brought around the Horn and used for many years to call people to service. A plaque was placed on this bell by Fort Bragg Parlor No. 210 in 1983. Member Betty Carr treated us to a short tour inside the church and related some of its history. We ended our tour of the town at Golden West Saloon which was opened by Gus West in the early twentieth century and has now been purchased by new young owners and is being refurbished. The bar back was rescued from a brothel that had been on an island off the mill property.

On Monday, the parade takes place on the streets of Fort Bragg commemorating the logging days and community activities. ## Dixon United Methodist Church

On Sunday November 6, 2016 the landmark Dixon United Methodist Church celebrates the 150th anniversary of the original Sanctuary building. Located at the corner of N. Jefferson and B Street, it is the oldest building in the city of Dixon. The history of the church dates back to March 1858 when the Methodist Society was organized in the village of Silveyville. Silveyville was an old Pony Express Stop. The young church first met in a school house and then for a short time in a hall over a saloon. By 1865 Silveyville had 150 residents. In 1866 the congregation began construction of their church. In 1868, the California Pacific Railroad came through the area. The residents of Silveyville were disappointed to discover the tracks missed Silveyville by a few miles. The town of Dixon sprung up along the new railroad tracks and became the hub of business and activity in the region. Gradually the entire town of Silveyville, buildings and all, moved to the new town. Dixon became the city that Silveyville started out to be. Do not bother looking for Silveyville on any map of today. Silveyville is listed by the state Office of Historic Preservation as a point of interest. In 1977, the Dixon District Chamber of Commerce placed a large metal marker at the Silveyville site (Silveyville Road near Schroeder Road) to help people remember the town-that-once-was.

In 1870 the First Methodist Episcopal Church of Silveyville was moved to the new town of Dixon on huge log rollers pulled by a team of mules. The church building proved to be too large and heavy to be moved across the railroad tracks where the town was located. It was left at its present site about 100 yards on the wrong side of the tracks. This was actually fortunate since most of the town burned in 1883. During church services, we are reminded of our history each time a passing train blows its loud whistle. In the 1870s, a 3/4-ton bell from Ohio was added as well as a parsonage. Over the years many improvements gradually occurred including an added office space, classrooms, and a large fellowship hall with a kitchen. Following the Loma Pieta earthquake (epicenter about 100 miles away), the bell tower became unsafe. The bell was removed, the structure reinforced and the bell is now housed in a new steeple added in 2011.

On the 9th of October 1955, the Mary E. Bell Parlor of the Native Daughters of the Golden West presented the bronze plaque which is proudly displayed on the front of the church.

Today, the church is a true part of the com-



munity. In addition to Sunday school, church services, weddings and funerals, the Dixon United Methodist Church is the meeting site for many groups including Dixon Historic Society, Toastmasters Club, Boy Scout troops, Alcoholic and Narcotics Anonymous. Due to its excellent acoustics, the original sanctuary is used for music recitals and performances. The parsonage, now called Friendship House, provides additional meeting space.



# California Under 12 Flags

September is not just Membership Month, but also a "California" month with the added celebrations of Admission Day and Founders Day.

With these thoughts in mind, Past President, Helen Leiva of Grace Parlor No. 242, showed an exhibit and gave a speech about the twelve flags that have flown over California from 1542 to the present day. It's an education of our

history, as well as appealing to the eye. Each flag was cut, sewn and hand embroidered by several members of Pasadena Parlor No. 290 in the early 1950s. Four sets were made and two are still in existence. One set was given to the Pasadena Main Library in 1957 and another to the famous Huntington Library in 1963. Presenting the set every few years to our Parlor gives new members a chance to hear the California Flag story which is scripted after the booklet published in 1927 by the Automobile Club of Southern California entitled, "California Under 12 Flags."

The flags represented are of the Spanish Empire, the flag of England, the Spanish National ensign, the flag of Russia, the Russian American Co, the flag of a Privateer, the flag of the Mexican Empire and the Mexican Republic, the flag of John Charles Fremont, the first (very crude) Bear flag, the American flag of 1846 with only 28 stars, and lastly the official Bear flag of California. When California considered a state flag, it seemed quite appropriate to adopt the Bear flag. It was redesigned from the first crude flag made earlier. On February 3, 1911, by legislative enactment, it was made the state standard. Today, the Bear flag hangs over every major State building from Oregon to Mexico, reminding us of all those who have gone before us, the explorers and mission fathers, trappers, Spanish settlers, the 49ers, and all others who shared in shaping this great state of California.


