## Welcome Amapola Parlor No. 338!

A momentous occasion occurred in the Order on Sunday, March 26, 2017. Amapola Parlor No. 338, Sutter Creek, was re-instituted. The event was held at the Sutter Creek Auditorium with over 150 people in attendance, including the largest number of Past Grand Presidents assembled outside of the Grand Parlor Annual Meeting. The Grand Officers conducted the formal Parlor institution ceremony and initiated thirty-seven new Sisters who were all wearing black attire with lovely poppy corsages.

Following a delicious catered lunch, the Parlor officers were duly installed by the Native Daughters of the Golden West Grand Officers. Since Amapola is Spanish for "poppy", Senior Grand Trustee Dawn Dunlap gave a historical



account of the events that led to the scientific naming of the California poppy -"Eschscholzia californica". The Sisters of Zinfandel Parlor No. 337, Lodi, passed the torch as the most recent Parlor instituted to their Amapola Sisters with the gift of a coin march basket. Zinfandel Parlor jokingly remarked they were growing from the "baby" Parlor to a "toddler".

Notable Native Sons in attendance included the current 1st Grand Vice-President (and Amador County resident) Erik Christeson of Excelsior Parlor No. 31 and Grand Inside Sentinel Jerry Stinson of Georgetown Parlor No. 91, and many other members and officers of Amador County's three Native Sons of the Golden West Parlors.

The Order owes a huge debt of gratitude to the Parlor organizer, PGP Marilynn Rodrigues,



and advisors PGP Marilyn Bustillos and Supervising District Deputy Grand President Nina Coffenberry who were instrumental in making this journey possible. The local Native Sons of the Golden West Amador Parlor No. 17 stepped up to help with Fundraising efforts, including a sold-out Harvest Party last November. The local community's support of their efforts was remarkable. 

Following in her mother's footsteps, Jean Sheppard joined Argonaut Junior Unit No. 3 on April 28, 1967 at the ripe old age of 13. Her mother Helen Tullius was a Charter member of the Junior Unit. Helen was a 50-year member and her grandmother, Claudia Evans was a 75-year member of Argonaut Parlor No. 166. Jean was involved with Native Daughters from the time she could walk in the parades with her family. Later, as an active member of Argonaut "Cubs" Junior Unit No. 3's Drill Team, she would march in the Admission Day Parades. She also presented the flags at the memorial services at Chapel of the Chimes in Oakland just as her mother and grandmother had done in prior years.

## **Early Native Daughters as Authors**

While searching the Internet for information on early members of the Native Daughters of the Golden West, I discovered some fascinating material having to do with publications such as booklets. Some of these involved Lilly O. Reichling Dyer, Founder of the Order, as well as a few Past Grand Presidents.

Cora Bonestel Sifford of Buena Ventura Parlor No. 95, Ventura, and later of Reina del Mar Parlor No. 126, Santa Barbara, served as Grand President at the 1900 annual meeting in Jackson. She served on the Order's Ritual Committee for many years, and chaired it during the 1920s. Prior to 1902 Mrs. Sifford wrote "The Sifford study of the ritual." This featured explanations and expansions on the meaning of phrases within the Ritual of the Order. The intent was to invite an officer to read from the paper under Good of the Order at regular meetings. Pictured here, Cora with a child in a bird sanctuary in 1931. In 1902, the study was printed along with an "outline for the study of California history" arranged by Eliza D. Keith. Also included in the booklet were poems, a circular letter, and a report from the Order's Historical Landmarks Committee. Miss Keith presided as Grand President in 1903 in Red Bluff. She was a school principal in San Francisco, a poet and a public speaker — also a "suffragist." An achievement by members of the Order resulted in publicity for sponsorship of the naming of Junipero Serra Peak in the Santa Lucia Mountains. On August 5, 1907, the Salinas Daily Index announced that Santa Lucia's highest peak had been renamed for Father Serra, a movement begun at the Grand Parlor

session in Salinas in June 1906. The secretary of the United States Geographical Board "officially informed Mrs. Lily O. Reichling-Dyer (sic), founder of the order of Native Daughters of the Golden West, that her efforts and those of Cora Bonestel Sifford and Harriet Stoddard Lee...have been successful."

In the spring of 1917 Mrs. Dyer copyrighted a seven-page booklet entitled "An Epitome of Facts and Events Relative to the Founding of the Order Native Daughters of the Golden West." It was compiled by the charter members of Ursula Parlor No. 1, N.D.G.W. The booklet contains the names of the first parlor members, an account of the founding meetings, and a list of the parlors instituted by the Mother Parlor. In late 1916 the document was signed and notarized. A book published in San Francisco in 1918 by Harr Wagner Publishing Company called Literary California Poetry Prose and Portraits was "gathered by" Ella Sterling Mighels (pictured right). She was an author who was a member of Hayward Parlor No. 122. At the 1918 Grand Parlor session in Santa Cruz a motion was made by Dr. Mariana Bertola P.G.P. to endorse the publication. This pleased Mrs. Mighels, who was a delegate, and she dedicated the book to the Native Sons of the Golden West and the Native Daughters of the Golden West. Included in the pages is "A Thought from Lilly O. Reichling Dyer" that reads "Very little is enough for us to live on; it is not clothes, it is not luxuries that give to us our greatest happiness, it is that which is within--our inward resources. It is my belief that what we plan, even with our greatest effort, can never equal that which comes forth spontaneously as if by inspiration."


As a 35-year Member of Grace Parlor No. 242, Sherry has served in many Parlor positions, including President for three terms and Past President. She has also served as Deputy Grand



## **Childrens Foundation In Action!**

The Childrens Foundation Committee recently was given a request from the Presbyterian Intercommunity Hospital (PIH) Neonatal Intensive Care Unit (NICU), Whittier, California. The Committee has approved part of their requests, which will directly have an impact with the little babies that may be born too early or happen to be born with any serious health issues.

What is a NICU? It is a nursery within a hospital that has the capability of providing a full range of neonatal care services for severely ill newborns and infants.

At PIH Health Hospital, Whittier, the NICU is equipped to handle a wide range of difficulties. Even newborn infants born at 23 weeks or with extremely low birth weight of 480g (about one pound) or who have severe or complex illnesses, can be treated there successfully without the necessity of a transfer to another facility. This NICU Unit, is a level IllB NICU, which means that they treat newborns who require intensive neonatology medical oversight with highly skilled nursing and respiratory care staff, advanced respiratory support and physiologic monitoring equipment, laboratory and imaging facilities, nutrition and pharmacy support.

One of their requests was for a microwave. This microwave will be dedicated for use by mothers who stay during the day and pump their breast milk to be used later by their baby. These moms use the hospital grade pumps while visiting their babies, and are encouraged to pump while near their babies, but they would normally only be able to pump once while at the hospital, as they would have to sterilize their pump kits when they returned home. The microwave allows them to sterilize their

pump kit equipment as often as necessary while at the hospital.

The donation of the microwave took place recently when our Grand President Sherry Farley and Childrens Foundation State Chairman, Dorothy Rogers and some of her committee members were in the Los Angeles area for the Southern Counties Childrens Foundation Luncheon. They also were taken on a tour of the NICU Unit, and were greeted by staff members, one of the dietitians, nurses and doctors that take care of these very special babies. They were delighted with our donation and were grateful for the interest that the Childrens Foundation has in their NICU Unit.

PIH Health Hospital is a non-profit hospital, and donations are received through their PIH Foundation, Whittier, California, which is a 501(c)(3) non-profit entity.

In the future, more stories from the Childrens Foundation will be published in the California Star, so the members of the Native Daughters of the Golden West may know of the varied cases we help fund. You will also learn more of what is happening at the PIH Health Hospital, Whittier, NICU Unit and in what ways we are helping the little babies who need so much help to get strong and leave the

### Dedication & Marking: Teale – Lehman House Lake Skinner, Riverside County

## **Jessie Jane's Dress and More**

Mygrandmother, Jessie Jane Dillian, was a collector, an informal collector, a local collector. She didn't search antique shops for collectables. In fact, she was an "indigenous" collector. She just kept hold of local odds and ends that came her way, and stored them in an old set of dresser drawers and an old cedar trunk, both of which sat in the tiny shed at the corner of her back yard. Entering that little

shed was an adventure,

an informal, charming journey into my grandmother's very local, very collectable life. The shelves on the north side of the little room were filled with colorful jars of canned fruits and jams, and a few stacks of red and green 16-gauge and 12-gauge shotgun shells.

But it was the dresser and the trunk that led us back to her collectable journeys through life.

Opening a drawer could result in a stack of colorful, pre-cut/pre-sewn cloth squares, all set up for whoever in the future might decide to make a quilt out of familiar pieces of our family's leftover blouses and dresses, shirts and skirts.

Carefully set in the top drawer, a small

A wooden box held a treasure trove of beautifully illustrated cards, cards which were included in the pounds of coffee she ordered over the years. Another album was filled with Victorian greeting cards. Also, there were her two lovely autograph books, with signatures and messages from youthful friends, many of whose

last names reflect Lincoln's history and early pioneer families.

Finally, carefully folded in the cedar trunk, there emerged a bright yellow and black dress. It is here, in this dress, that my grandmother's personality is delightfully displayed: She was a seamstress - who collected. It also helped that her husband, Frank Dillian, owned Dillian's Saloon, which turned into a gold mine of discarded General Gomez cigar box ribbons.

I'm not sure how surprised Jessie Jane would be if she could be told that her playful cigar ribbon dress has become relatively famous, appearing in various news items, magazine articles, featured on Antique's Road Show, and charmingly displayed in the Lincoln Area Archives and Museum. Perhaps she wouldn't be so surprised, since it is all so local. Her dress is displayed in a museum one block from her home, a half a block from her little shed, one block from her husband's saloon. The museum, the dress, the saloon, her home, the little shed, it is all so homemade and indigenous.
