N.D.G.W. Roll of Honor Recipients for 2020-2021

This year the Roll of Honor Committee had the privilege of reviewing the nominations of two outstanding women who have done much for the State of California as well as the Native Daughters of the Golden West. Pursuant to our Constitution, these ladies are not eligible for membership in our Order but have certainly emulated our love of the State of California. The nominees both exemplify the words of our Motto: "...to preserve California's history and better the quality of life through active participation in education and community service." And the Roll of Honor Committee is proud to recognize both nominees.



The first nominee was recommended by El Vespero Parlor No 118, in San Francisco. Their Parlor nominee was for Tara Vanderveer, "the winningest coach in women's college basketball." Ms. Vanderveer was born in Melrose, Massachusetts and grew up in New York. In 1983, she moved to Palo Alto, California to coach women's basketball for Stanford University. Ms. Vanderveer has spent the past thirty-three seasons as the head coach of the women's basketball team and is currently the Director of Women's basketball at Stanford.

Coach Vanderveer has established herself as one of the top coaches in the history of collegiate and international women's basketball and has been inducted into the both the Women's Basketball Hall of Fame (2002) and the Naismith Memorial Bas-

ketball Hall of Fame (2011). She is one of only nine NCAA Women's Basketball coaches to win over 900 games and one of ten NCAA Division I coaches - men's or women's - to win 1,000 games. On December 15, 2020, she surpassed Famed University of Tennessee Coach Pat Summit for the most wins in women's basketball history. As of February 3, 2020, she has won 1,099 games! **The Stanford Cardinal women, under Coach Vanderveer's leadership, also edged out the Arizona Wildcats by winning the 2021 NCAA Women's basketball Tournament by a score of 54 to 53!** Under Ms. Vanderveer's expert coaching, her players have received the following honors: two Wade Trophy Player of the Year honors, two Naismith Player of the Year honors, 31 first-team-All-American honors (WBCA and Assoc. Press), 18 Pac-12 Player of the Year awards, 77 first team All-Pac 12 selections and nearly 40 appointments to USA Basketball teams.

During the Covid-19 pandemic, Ms. Vanderveer has donated \$10 for each career win - over \$11,000 so far - to local food banks in California. Her donations have helped provide approximately 55,000 pounds of food to those in need.

In recognition of Ms. Tara Vandeveer's lifetime career dedicated to coaching and guiding young women in California sports and life skills, the Native Daughters of the Golden West Roll of Honor Committee is proud to honor Ms. Tara Vanderveer as the 77th recipient of our Roll of Honor Award, since its inception in 1910! Congratulations!



The second Roll of Honor nominee was submitted by Joaquin Parlor No. 5 of Stockton. Their nomination was for Dr. Judith Chambers. Judith Chambers was born in Philadelphia, and moved to California with her family when she was two years old. She



graduated from the University of the Pacific in Stockton (UOP) in 1958 with a degree in Speech with honors, followed by a Master's Degree in 1960, and Doctorate of Human Letters from Heidelberg College in 1987. Dr. Chambers was Professor of Speech at UOP and her career focus was the education of college students. She was the first female Vice President of Student Affairs, and Special Assistant to the Vice President for University Advancements. Many organizations have recognized Dr. Chambers for her exemplary efforts in mentoring students at UOP, including the US Department of Education for contributing to the Standards of the Network to Promote Drug-Free Colleges and Universities, co-chairing the US Secretary of Educational Regional Forum in Excellence in Education, and President Reagan's appointment to the Board of Directors of Student Loan Marketing

Association, and Governor Wilson's appointment to Western Intercollegiate Commission on Higher Education.

Although now retired, Dr. Chambers was heavily involved in serving the community of Stockton in equalizing the rights of women in athletic opportunities, oppressive hours and dress codes. She served as President of the National Association of Student Personnel Administration (NASPA) and on the City of Stockton's Year of the Youth Task Force Committee, Business Leadership Summit that worked with emerging young adult leaders. Dr. Chambers has received many awards for her tireless service to UOP students, including the three highest awards given by NASPA for Student Affairs Leadership: Fred Turner Award for Outstanding Service to Student Affairs Profession, the Scott Goodnight Award for Outstanding Performance as a Dean, and Pillars of the Profession.

The Native Daughters of the Golden West Roll of Honor Committee is honored to award Dr. Judith Chambers as the 78th recipient of our Roll of Honor award, since its inception in 1910, in recognition of her life-long dedication to the education and betterment of women and children of our Golden State/ Congratulations Dr. Judith Chambers!







We are hoping to contribute \$550 dollars each, to Point Fermin Lighthouse, Piedras Blancas Light Station, Pidgeon Point Lighthouse and the Point San Luis Lighthouse. We received \$705 from the NDGW, Charitable Foundation, Inc Committee. These \$705 amounts were evenly distributed, to our committees, from the "Cash for Christmas" fund raiser. This amount along with generous contributions towards the Lighthouse Steps can help us reach this goal! Two of these restorations involve fog signal buildings, electrical, lighting and flooring. One involves the restoration of cisterns as well as general building repair and maintenance. The fourth wants to purchase historically accurate reproduction lace curtains to "compliment the setting as a formal receiving area, circa 1874."

Grant requests can be given for school and educational programs having to do with lighthouses as well.

The committee's main function is philanthropic in nature. Of course, the raising of funds at an event, that also tours and teaches about lighthouses, is a perfect combination. We are still hoping to have a fund raising event on the USS Potomic, President Roosevelt's floating Whitehouse, that will take us to see some lighthouses in the San Francisco Bay. That will have to wait a bit longer. Several calls have been made and I have been assured that we will be notified as soon as they start booking trips again. Keep an eye out for fall or spring of 2022 for our trip.

The more money we can raise, the more we will have to give. The lighthouses have all taken a financial hit this year. Many had trouble responding to our requests because of short or no staffing. Any and all help will be very much appreciated.


