# The Native Daughters of the Golden West Home

Our beloved Home embodies more than just a place for meetings and overnight stays. For our membership it represents a place of Refuge, Relief, Respite, and Rest.

The establishment of our four Homes was a long and arduous journey by our enlightened leadership and dedicated membership. In 1892, S.P. Rodgers, a Member of the Native Sons of the Golden West, our California born Brothers who share many of our common goals, left \$600.00 in his estate to the Native Daughters with the stipulation that the funds be used

for the aid and comfort of the Members of our Order, and administered by an entity separate from Grand Parlor.

A Board of Relief was quickly established and incorporated to administer the restricted bequest. A group of Past Grand Presidents carefully developed a plan for a place to serve as a hospital, home, and club that provided security, comfort, and friendly companionship for our Members. It was presented to the Delegates at our Annual Corporate



Convention in 1898 and enthusiastically adopted.

Among this group of Past Grand Presidents were Tina L. Kane, Clara K. Wittenmeyer, and Dr. Mariana Bertola. The Board of Relief rented a residence at 925 O'Farrell Street in San Francisco, and established our first Native Daughter Home. It was formally dedicated on January 2, 1899.

The second floor of the Home was fitted out with all of the medical furnishings and equipment of a hospital wardroom with a staff of trained nurses and ten physicians on call. All of which was solely underwritten by one San Francisco Parlor, Buena Vista No. 68. The hospital wardroom and its attending staff were available free of charge to ailing Sisters recovering from operations, or suffering from non-infectious diseases and in need of medical attention and care.

This Home included a kitchen, formal dining room, meeting rooms, and lodging rooms on the ground floor for Members visiting or residing in the City. Why did our Home include a hospital wardroom?

At this time there were no governmental welfare agencies providing medical aid to those in need. All Subordinate Parlors were responsible for the care of their Members including funding for medical fees and costs. Each Parlor contributed \$3.00 to a Member Relief Fund that maintained the hospital wardroom. This was all part of our Sisterhood. From 1898 to 1905, additional funds from Subordinate Parlors, and outright donations of monies and furnishings were received by the Board of Relief from Members for the Home. Looking to the future, the Board of Relief opened a savings account toward the purchase of our second Home.

In 1903 a larger residence at 1113 Hyde Street was purchased and outfitted to meet our Members' growing needs. Like many San Francisco residences and businesses our second Continued on page 10

# **N.D.G.W.** Donates to Town of Paradise at Wildfire "Remembrance Day"

The 2019-2020 N.D.G.W. Americanism and Civic Participation Committee Members, Mary Kingshill of Ruby Parlor No. 46, Murphys, and Shirley Svindal and Gayle Gleim (State Chairman), both from

Golden West are honored to support the wildfire recovery of the town of Paradise November 8, 2019

San Jose Parlor No. 81, were privileged to be invited to be guests at the "Remembrance Day" events in the town of Paradise, which commemorated the one-year anniversary of the Camp Fire that devastated the Town in 2018. Also attending the Remembrance Day on November 8, 2019, was Barbara Seaton of Sutter Parlor No. 111, Sacramento, Deputy Grand President to South Butte Parlor No. 226, Sutter.

In accordance with the Americanism and Civic Participation Committee's constitutional charge to "promote good citizenship through the preservation of the ideals of the American Way of Life" and to "encourage members of the Order and subordinate Parlors to participate in community projects thereby stimulating public

awareness of the principles and projects of the Order and assisting in building a better community and State," this term's Committee decided to donate \$1,000 towards the construction of a storage shed to hold the flags used for the Paradise "Parade of Flags." This tradition of displaying American flags on the Town's main street three times each year — on Veterans Day, Memorial Day and Independence Day — suffered a major setback when the Camp Fire destroyed 95% of the structures in the Town, including the previous storage facility which contained



1,000+ flags. According to Steve Crowder, a Paradise town Council Member, over the past year they have received donations to replace all the flags lost in the fire, but have been raising funds to erect a building to store them. The town was able to display 85 flags on the Remembrance Day to memorialize the 85 victims of the fire.

At an afternoon community meal for approximately 2,000-2,500 people held at the Paradise Alliance Church (a large complex of several buildings that survived the fire), the N.D.G.W. State Committee Members formally presented the donation check and a small plaque, which will be attached to the completed storage shed that reads: : The Native Daughters of the Golden West are honored to support the wildlife recovery of the town of Paradise

The meal was hosted by World Central Kitchen, a non-profit organization established by noted Spanish-American chef Jose Andres, which since it's inception in 2010, has provided over 3 million free, healthy meals in the wake of major disasters worldwide with the help of local chefs and utilizing selfcontained food trucks and food supplies and service from local volunteers. Chef Andres and his crew returned to Paradise to provide the Remembrance Day meal.

Earlier in the morning, the Remembrance Day activities included the

- Opening of the Paradise Resilience Center — a "one stop shop" for fire victims where advocates help survivors navigate through disaster recovery resources, insurance claims, building permit processes, etc.; the
- Unveiling of the "Key Phoenix" Sculpture (inside the Resilience

**Center)** — created by a local female artist who collected 18,000+ keys from the destroyed homes, cars, businesses, etc. of local residents and used them to form the figure of the mythological Greek Phoenix, a bird that dies in a show of flames and is reborn again, rising from the ashes of its predecessor, symbolizing renewal; and the

Groundbreaking of Hope Plaza — the planned landmark, a former parking lot site, is being designed to honor the Camp Fire's first responders, heroes and victims and to inspire hope for the future of Paradise by including a park-like setting with benches, water features, and a "Forest of Honor"— a wall of tall stainless steel trees engraved with the names of the 85 locals who perished in the fire.

The Paradise Remembrance Day was both a sad and glad experience. It was difficult to witness the extent of the fire's devastation of structures, vehicles, trees and vegetation, and at the same time it was heartwarming to see all the people — first responders, government officials, citizens, volunteers — be so gracious and welcoming in spite of their struggles. It was humbling to feel the positive spirit evident with everyone, even as the suffering from this horrific disaster persists. The Americanism and Civic Participation Committee Members were touched by the friendliness and hospitality demonstrated at the Remembrance Day, and we were proud to represent the Native Daughters, an organization that continues to truly care about the welfare of our fellow Californians and our State.

# Extension of the Order



Home and all of its furnishings and contents so generously donated were destroyed in the conflagration after the Great Earthquake of 1906.

Of our many Parlors in San Francisco, only two survived unscathed by the earthquake and fire. Our Order's efforts of addressing the responsibility of feeding, housing, and meeting the medical needs of our distressed Members who had lost everything were unprecedented. For two years our Sisters who were ill and in need of assistance were housed and cared for in various Members' private homes in San Francisco.

Many of our Sisters on both sides of the Bay also provided daily acts of true charity to hundreds of the displaced citizens of San Francisco.

As we still owed \$1,950 on our mortgage for the Hyde Street Home, we sold the burned-out lot for \$2,500. Subordinate Parlors throughout the State raised additional funds with bazaars, rummage sales, and theatre parties to fund and establish our next Home. The Board of Relief name was changed at this time to the Home Committee. By June of 1913 \$6,000 had been set aside and a two and one half story residence with an adjoining lot on Baker Street was purchased and refurbished as our third Home. Once again Buena Vista Parlor No. 68 provided medical furnishings and equipment for our hospital ward, and other local Parlors provided the furnishings for the House matron's room, and six bedrooms for our visiting and residing Sisters. Additional funding was requested by Grand President Olive Matlock first in the form of a penny-a-week pledge from our 8,000

In 1919 the voluntary pledge turned into a mandatory Annual Home Assessment of \$.50 per Member. In 1924, an adjacent residence on Baker Street was purchased and utilized for additional lodging rooms for our Members.

Members.

Dr. Bertola worked closely with her friend Miss Julia Morgan to convert both residences into one large structure by exploring a means of connecting the two buildings with a tunnel. Despite numerous plans and proposals, this desire proved impractical.

(However, several years later Miss Morgan was successful in connecting her adjacent apartment houses on Divisidero Street with a tunnel.)

The Home Committee made the decision to

tear down the two residences and build an entirely new Home.

In 1927 Grand President Grace Stroemer promoted the idea and received an avalanche of \$100 donations from Subordinate Parlors toward the project. Miss Morgan and Dr. Bertola combined their practical and creative talents, and designed our beautiful fourth Home that we are all privileged to enjoy.

A unique quality in all the structures designed by Miss Morgan was the particular attention she placed on the interaction of air and light in every room.

She truly designed a structure from the inside out. The Home was formally dedicated on January 12, 1929.

Fifteen hundred Members and guests toured the Home that day, and five hundred attended the formal dedication reception that evening.

The flaming torch emblems adorning the iron gates at the entrance symbolize our Home as a place of protection and safety.

They were generously donated by the Native Sons. The Grand Parlor Office, two Parlor meeting rooms, and a large meeting room were located on the first floor.

Miss Morgan had originally planned the large meeting room (now known as the Bertha Briggs Continued on page 11

Auditorium) as a salt water plunge, but replaced that idea at the behest of Dr. Bertola who lobbied for a large auditorium for our formal meetings with their ritual pageantry.

The first and second floors had three stone fireplaces and mantels and Persian rugs.

The formal parlor was graced with fine furniture, crystal chandeliers, oil paintings depicting beautiful California scenery, books of varying interest, and a grand piano.

The kitchen was equipped with the latest appliances, cookware, crockery with the NDGW monogram (which we still use), and glassware.

Subordinate Parlors, Members, and friends made monthly donations of groceries, including fresh fruit and vegetables from their farms and orchards.

The third floor provided lodging for our Members.

One wing of the fourth floor was the hospital wardroom furnished and equipped, once again, by Buena Vista Parlor No. 68.

The remaining rooms in the other wing of the fourth floor were also utilized lodging for our Members.

Miss Morgan's original blueprints depict a roof garden much like the one atop the Hotel Hassler in Rome. This never came to fruition, but in September 1930, the Native Daughters Home had a pee wee golf course installed on the roof. It was purportedly much-loved, but short-lived. having been abandoned as being too expensive to maintain.

The total cost of constructing our steel frame and concrete Home was Ninety-One Thousand Dollars.

A mortgage was obtained by Dr. Bertola in behalf of the Native Daughters from her friend Amadeo P. Giannini through his San Francisco-based Bank of Italy.

This business arrangement took place shortly before Mr. Giannini bought a small bank in Southern California named Bank of America which soon gave rise to his merging the two and abandoning the bank's former name.

At our Annual Corporate Convention in 1929 Grand Secretary Sallie Thaler and Grand President Dr. Louise Heilbron presented and promoted the idea of a voluntary donation called The Loyalty Pledge that would require \$5.00 assessment per Member.

It was a grand success.

On August 14, 1932 the mortgage documents were ceremoniously burned; paying this entire debt off in three years at the beginning of the Great Depression was a most worthy achievement. At this time we had visiting, temporary, and permanent residents staying at the Home.

Our records show that in July of 1929, 24 Members were living in the new Home paying \$45.00 a month for room and board.

Dr. Bertola who served as the head of our Home for 47 years (from 1906 to 1953) took particular interest in encouraging young women to come and work in San Francisco.

She provided them safe shelter in our Native Daughter Home and counseled them in becoming self-supporting.

Those fortunate enough to come under her protection and tutelage were referred to as "her girls". In 1939 an adjacent residence on Baker Street was purchased by Grand Parlor, and rented out to provide additional income for the Home.

Past Grand President Emma G. Foley was the Home Committee Secretary for 23 years.

In 1945 her estate distributed property in San Anselmo (Marin County) that she had bequeathed to the Native Daughters.

She had hoped that the property would be utilized as a Summer Retreat for our Members. Instead the property was rented out, and the monies applied to the maintenance and repair of the Home.

In 1959 at our Annual Corporate Convention a controversial proposal was introduced to sell the San Anselmo property and construct a new building on Baker Street.

After much discussion, it was narrowly adopted. The property was sold for \$21,000. Over the next few years additional funds for

the project were collected, and the money invested.

In 1964 the rental residence next to the Home was demolished and a new building was constructed.

It was designed by Harada and Meu, and built by Empire Construction Company.

At an Open House on June 17, 1964 the structure was formally dedicated as The Emma G. Foley Wing.

The building included a social hall, kitchen, and garages on the first floor, as well as a Historical Relics Room to house and display the many relics donated to the Order by our Members, and an additional recreation room for the residents of the Home. At our 1959 Annual Corporate Convention a resolution was passed directing the California History, Landmarks, and Historic Buildings Committee to investigate a suitable place to display and store the relics that had been donated to the Home.

Past Grand President Evelyn I. Carlson was appointed State Chairman of the Relics Committee, and spearheaded the effort to collect additional historic articles or relics for the proposed Historical Relics Room.

In June 1966 the Historical Relics Room was furnished with display cases and opened for the viewing pleasure of our Members.

The Room also housed our Roster of California Pioneers and Landmark files.



In the mid-1980s, great changes were made in the Home and the Foley Wing.

In 1985 the Grand Parlor Office was moved to the former Recreation Room in the Foley Wing.

Due to an insufficient number of residents the residence program was discontinued on October 1, 1986.

Our records indicate that the remaining

permanent residents were each paying \$375 a month for food and lodging.

The Home Committee was paying a staff of four to provide care and services to five women. In 1987 the Historical Relics Room was rechristened the Evelyn I. Carlson Native Daughter Historical Collection and the collection of artifacts were dispersed

"A house is built of


