2019 Roll of Honor

The Roll of Honor award is given to women who are not eligible for Membership in our Order but have mirrored our love of the State of California. The Roll of Honor inductee this year was Beverly Ann Fitch McCarthy. She was born on August 10, 1933, in St. Louis Missouri. She was nominated by Joaquin Parlor No 5, Stockton. She has lived in the State of California since the age of 14 and she has lived in Stockton since 1962. She has degrees from Stanford University and University of the Pacific.

Mrs. McCarthy has worked tirelessly for the rights of women. Some of her achievements include 23 years of employment as a college counselor/instructor in psychology, marriage and family, dance, and individual conditioning. She was the first director of the Delta College's Re-Entry Program for Women and Chair of the San Joaquin County Commission on the State of Women. She co-chaired the 150th Celebration of Women's Suffrage in Stockton and served as California's elected delegate to the National Women's Conference.

Mrs. McCarthy has received numerous awards, for her work in childcare, for founding the San Joaquin County Commission of the State of Women and for the institution of the Susan B. Anthony Woman of Achievement Awards.

Mrs. McCarthy has been a committed feminist for more than 40 years and continues to fight for women. In March of 2018, due to her efforts, the Stockton City Council unanimously adopted the Resolution to eliminate all forms of discrimination against

women. With the passage of this pact, the City of Stockton will promote equal access to and equality in health care, economic development, educational opportunities and employment for women, and it also addresses violence against women.

In summary, although she retired from Delta College in 1985, she continues to be a mover and a shaker in Stockton, the county of San Joaquín and the State of California. She is a feminist, political activist and social reformer. She has devoted her life's work to the benefit of women and children in our Golden State. Her endeavors have benefitted many of our Sisters by her work in women's rights, educational goals, and reentry to places of higher education plus childcare assistance in San Joaquin County.

This is just a short summary of her activities and achievements.

A plaque was presented in Mrs. Mc-Carthy's honor at the Grand Parlor Annual Meeting in Fresno that reads:

In recognition of your untiring work for and devotion to the women of California.

For your work as an educator, feminist, political activist and social reformer

For your continued commitment to better the quality of life through active participation in education and community service

Presented by the Native Daughters of the Golden West Grand Parlor, June 20, 2019.

Her name has been added to the Roll of Honor plaque which includes 74 other woman who have contributed in some way to the betterment of Califirnia.

"I came to California expecting a miracle; having found none I made my own." From a letter written in the 1870s, by an unknown author.

Dear Sisters,

All of our forebearers, no matter if they arrived in 1775 or 1945, came to California full of hope, seeking opportunity. All of them sought to make their own miracles, and many of them surely achieved their goal.

It is time for the Native Daughters of the Golden West to make their own miracle

through membership, funding, and public relations. I have proposed a triangular plan wherein the three foregoing entities will lead us to achieve our own miracle.

Membership — Each of us must make a commitment to our Parlor and our Order to sponsor at least one new Member this term. I shall be sending sponsors of new Members one of my pins. I suggest that you always have an application and a NDGW brochure in your purse and another set in the glove box of your car. When someone asks what you've been up to lately, have a response ready that includes social events

within your Parlor, how your Parlor is engaged in bettering your community, and share your most recent stay at the Native Daughter Home.

Everyone wants to belong to something bigger than their own sphere. Present prospective applicants with something they want to be part of, something appealing and enticing. As our applications are complicated and confusing to many, avoid handing out a blank application. Take time to explain the NDGW brochure and fill out, on the spot, as much of the application as you can. Know the amount of your Parlor's initiation fee and dues for six months. If you are in the company of another Sister, both of you should offer to sponsor the prospective applicant. Give her your name(s), phone number(s), and e-mail address(es). Offer to help her complete the application, then ask her to write and mail the check and proof of her California birth to you. Be sure to secure the prospective applicant's contact information. If you do not hear from her in ten days, give her a call. Engage, encourage, and enlist! I personally am accepting the challenge of sponsoring fifty new Members in my fiftieth year in our Order. What will be your membership

goal for this term?

In the next issue of California Star, I shall have a report from the Extension of the Order Sub-Committee that is promoting and establishing a Junior Native Daughters Unit in the Central Valley for girls and young women between ten and sixteen years of age.

Funding — Many of us are at an age when thinking about our estate plans is common. We have worked hard for what we have and need to think prudently about how and to whom we wish to distribute our assets. Consider making a bequest to the Native Daughters of the Golden West.

Another option is to consider a yearly endowment. You can leave a charitable contribution each year to a qualified charity of your choice. We have three qualified 501(c)3 entities; NDGW Home, Childrens Foundation, and CFIC (Charitable Foundation, Inc. Committee made up of ten public benefit state committees). The "Kitchen Cabinet" I have assembled will soon be seeking grants for our NDGW Home.

Public Relations — Our Childrens Foundation offers the best opportunity for publicizing the good works of our Order. In addition to meeting the medical, dental, audiological, and other needs of California's children, I propose we expand our Childrens Foundation to include embracing new ideas to benefit a wider circle of California's children.

We can fund extracurricular art and music programs in public and private schools, as well as art and music therapy for children on the autism spectrum. We can also offer much-needed relief for children who are victims of California's many natural and man-made disasters, wildfires, floods, earthquakes, landslides, and droughts.

In the next issue of the California Star, I shall share the Welfare Committee's program on women's health issues and available programs to aid our Members.

During my term I am looking forward to visiting each Subordinate Parlor and meeting many of our 4,300 Sisters.

In the meantime, I wish all my Sisters and their families a lovely Summer in our beautiful Golden State.

Installation Speech of Grand President Dawn Dunlap Presented on June 21, 2019 in Fresno, California

My journey through the Native Daughters of the Golden West began forty-nine years ago on Main Street in Cambria when Past Grand President Katie G. Jewett, who was my catechism teacher and a neighboring rancher on Santa Rosa Creek Road greeted me with a proposition. She said, "You need to join the Native Daughters, and if you do, I shall see that you're awarded a State Committee scholarship to UC Berkeley." She continued... "However, there is one condition you need to promise me that if you are given our scholarship, that you will be a lifetime Member." Well, that was the deal, and here I am.

You are surrounded by many shades of red this evening. The color red symbolizes joy and celebration, passion and action, intensity and spirit, fire, and for our Order - Courage. Tonight, the color red symbolizes the solidarity of the leadership of our Order. The solidarity of leadership in utilizing communication and collaboration to achieve the fraternal bond of our common goal of improving our culture and our society. That, dear Sisters is what we are all invested in doing for our communities... improving our culture and our society. And as your leaders, we are prepared and $most\,willing\,to\,share\,with\,you\,our\,knowledge$ and experience of our beloved Order of the Native Daughters of the Golden West. What a marvelous name!

The image of my pin is on the diamondshaped banner in front of the podium. The historical and multi-cultural Greek, Etruscan, Roman Goddess we know as Minerva is seated in the center with her spear and shield in hand, a sheaf of golden wheat at her feet. Her gaze westward, while guarding the Bay and its surrounding mountains. She was the goddess of poetry, wisdom, strategy, commerce, and crafts; all attributes necessary for a true Native Daughter. The gold letters and numerals surrounding the intaglio read "Native Daughters of the Golden West 2019-2020." The pins are still in process but will be available soon. Please recruit and sponsor new Members, and I shall send you one of these pins.

I encourage you to make Native Daughters part of your everyday conversation. You must live "Native Daughters" and express it in order to ignite the enthusiasm and interest in others to affiliate with our Order.

One of my favorite quotes from the 1870s, "I came to California expecting to find a miracle, having found none, I made my own," captures the spirit of being a Westerner. We too must embrace that spirit and take up the challenge of making our own Native Daughter miracle. I wish to share a plan for this term with you.

We must establish a triangulation of Membership, Funding, and Public Relations; they are inter-dependent for their strength and success.

The first arm of the triangle is Membership. I propose we seek ideas for promoting and establishing a Native Daughters Unit in the Central Valley for girls and young women between 10 and 16 years of age. What are girls and young women interested in being part of and contributing to? Let's offer them what they want to invest in Learning, in Doing, and in Being through the Native Daughters. Let's entrust them with the future of our Order in this ever-changing world.

We also have a most effective recruiting tool readily available to us; social media. We must use social media to interest women in their twenties to forties who are in college and/or building careers. We can develop a social networking platform to offer them a system of building relationships by sharing their lives with one another while promoting their careers and businesses.

The second arm of the triangle is funding. We need a large amount of outside funding. We can no longer wait for something to just come along or randomly happen. We must make it happen. We must go to that river of funding you hear about, a hundred thousand or a million dollars granted or awarded to a group from a local or national philanthropic organization. I suggest we take a water truck to that river of funding and not a teaspoon. Therefore, I shall be establishing a kitchen cabinet of Sisters with Dr. Lee Davis serving as our advisor to research and apply for endowments and grants. The endowments and grants we receive will build up our available funds to maintain and improve the financial infrastructure of our Order as a whole, as well as repair, restore, and maintain our wonderful Grand Dame... the Native Daughter Home.

The third arm of the triangle is Public Relations. Public Relations is where I perceive we can achieve the most progress in improving our culture and our society. In addition to meeting the medical, dental, and audiological needs of California's children, I suggest we expand our Childrens Foundation to include exploring and embracing new ideas for affording California's children a better future. I suggest providing opportunities for our children through funding music and art programs in public and private schools. Providing them not just education in music and art, but also buying instruments and supplies, and funding after school and weekend programs in the arts. I also suggest we fund the following through the Childrens Foundation: Therapy programs for children isolated by autism who are looking for a way to connect and express themselves. Mental health programs for children and young adults in trouble with no path leading them to wellness. Much needed relief for children who are victims of California's many natural and man-made disasters... wildfires, floods, earthquakes, landslides, and droughts. Surely, we all pay to live in this land of gold, but let's make a child or a young person's path a little less strewn with obstacles. Let's utilize the funds so generously left to us in Sisters' memorials and contributions more effectively by investing in innovative programs benefiting a wider circle of California's children.

I also wish to establish a women's health network of information and available programs to aid our Members. We must start with prevention and encourage our Members to place the care of themselves and good health practices above all their other responsibilities. Without our health, what have we? Look around you...we're all aging. You hear often your Sisters talking about their latest adventure in the medical or pharmaceutical world. We need to learn to recognize health issues before they get the better of us, we need to understand our medical options, we need to be aware of clinics, hospitals and programs available to help us, we need to be able to discern what health insurance is best for our needs. I suggest the mode in achieving these goals is through our State Welfare Committee. I anticipate that this Committee will be very pro-active; so be ready.

We must revitalize our State and Parlor Committees by thinking in new ways of balancing the innovation and change our culture and society demands with the tradition and conservatism that honors the history our Order. I believe the key is in making Native Daughters and our projects relevant in our lives, relevant in the lives of our Sisters, and relevant in our communities.

For my Official Visits, I shall be visiting each Subordinate Parlor on their regularly scheduled Parlor meeting date. My Calendar of Events, Special Days of the Order, and Official Visits will be sent out quarterly and updated monthly in the correspondence from the Grand Parlor Office. Regarding my Official Visits, please rest assured that I am not visiting each Subordinate Parlor to judge, nor criticize but to observe, participate, and answer any questions or concerns the Parlor Officers or Members may have. Overall, I am interested in taking the full measure of our Order by visiting all of the pieces that make

up the whole fabric.

I shall be encouraging our Subordinate Parlors to utilize the meeting scripts no matter how small their meeting space is, or no matter how few of their Members are in regular attendance. I shall invite the Parlor Officers to make the Manual of Instruction their new best friend. There is an amazing amount of very helpful information in those 60 odd pages. I especially am looking forward to touring the surrounding areas with my Parlor hosts and learning of each Parlor's history and of their work in bettering their respective communities.

There are five Parlors staging Anniversary Celebrations this term. They are: San Jose Parlor No. 81 celebrating their 125th Anniversary on July 27th, Placerita Parlor No. 277 and Toluca Parlor No. 279 celebrating their 75th Anniversaries together on October 26th, San Juan Bautista Parlor No. 179 celebrating their 110th Anniversary on February 22nd, and Forrest Parlor No. 86 celebrating their 125th Anniversary on April 4th. As I shall be staging my Official Visits to these Parlors separately, these are solely celebrations.

You have undoubtedly heard stories that I only eat steak. That is not entirely true. Although I love a tasty steak, I do eat all other types of protein. I love vegetables, but I'm not big on salads. I have a bumper sticker on one of my ranch pickups that says, "The West was not won eating salad."

As far as gifts, I am a bookaholic. I welcome books on the history of your local area. I also love plain linen or embroidered handkerchiefs. I ask that you please do not give me likenesses or statues of Holstein or other dairy cows. I raise Charolais beef cattle. You'll see pictures of my herd in the adjacent room where the Installation Reception is being held. Dairy cattle and beef cattle are apples and oranges; they all are not "just cows," but very different bovine.

In making my appointments I have assembled a talented hard-working group of Sisters from our Order who will take the triangle of Ideas and Programs that I described earlier forward to success. It is within our reach. We can make our own Native Daughter miracle. This miracle includes a larger, younger, and stronger membership, funding for our charitable programs and our beloved NDGW Home and making a better world for our children and a healthier life for our Sisters. I ask you to join with me, and together we can fulfill our mission of improving our culture and our society.




Take a Tour of Mission Santa Barbara from Your Home!





Penny Pines Reforestation Program

The forests of California were being ravaged by World War efforts, so the Pennies for Pines Program was started to get donations for reforestation. At that time, the seedling trees cost a penny and 680 seedlings could be planted on one acre. Sixty-eight dollars would plant ten acres. The Forest Service requests that

Forest Service requests that traditional dollar amount.

In 1941, California's first Penny Pines Plantation was sponsored by the San Francisco Sports-women's Association, and donation sent to Shasta-Trinity National Forest in Northern California. Many groups and individuals contribute to this day including Garden & Women's Clubs, Boy & Girl Scouts of America, civic and sportsmen's clubs and many others including schools.

In 1964, the original cooperative agreement evolved to include site preparation and planting, not just seedling purchases. Today, \$68.00 buys a one-acre Penny Pines Plantation of over 300 tree seedlings. Trees



of sixteen species are used throughout the state, including Ponderosa Pine, Jeffrey Pine, Douglas Fir, and Incense Cedar.

Given enough time, the land will recover from fire, pests, and disease, but Penny Pines lends a helping hand. It is a cooperative conservation program in which

everyone can participate.

Marguerite Parlor No. 12, Native Daughters of the Golden West has donated \$1,292.00 to the Penny Pines Program since 2010 resulting in 19 acres of reforested land. Sutter's Mill Parlor No. 336 started participating in 2016 and has donated \$204.00 resulting in 3 acres of reforested land. Both Parlors continue to collect for future donations.

Did You Know?

By Darleen Carpenter, El Tejon Parlor No. 239, Bakersfield (references from Native Daughters 100 Years Book)

Native Daughters of the Golden West had an adoption agency. In 1907, Mr. Fairfax H. Wheelan, a member of Pacific Parlor No. 10, Native Sons of the Golden West, was asked to assist Miss Katharine C. Felton, secretary of the San Francisco Associated Charities, in formulating plans to aid the homeless children of California. These children had little or no protection in those days and often were left to fend for themselves at a very early age. Adoptions were too often a matter of obtaining convenient extra workers in the home or on the farm. With the help of volunteer workers from both Orders, living in the same communities as the applicants for children, the children could be assured of a "guardian angel" nearby. These volunteers could help in the elimination of the unfavorable home and be in every-day touch, unobtrusively, with the child placed in the acceptable home.

The response of the Members was overwhelming, and the Central Committee on Homeless Children was established in 1909. The first child was placed for adoption in 1910. Each Parlor appointed a Homeless Children's Committee and funds were raised through many methods, including dances, raffles, and entertainments. Native Daughters from all over the State supplied layettes for the babies so they would go to their new homes dressed as well as the families' own children would be. A "milk fund" was maintained to provide for the care of the babies in their first six weeks in receiving homes. This care, sometimes up to three months, gave the parents time to possibly work out plans to avoid relinquishment of their children.

Parlors could also "adopt" a baby. Funds would be raised by the Members and then sent to the Central Committee, which provided a picture of the baby. The Parlors were allowed to "name" each of their adopted children.

Children were cared for prior to adoption in the Felton and Holsclaw Cottages on 30th Avenue in San Francisco and in White Memorial Hospital on North Boyle Avenue in Los Angeles.

In 1927, the adoption law of the State of California provided that agencies be licensed. Of the seventeen adoption agencies then in existence, only two were licensed, since they were the only ones deemed worthy to do excellent work for the children of the State; they were the Children's Home Society and the Native Sons of the Golden West-Native Daughters of the Golden West Central Committee for the Homeless Children.

Miss Mary E. Brusie served as the Secretary of the Central Committee from August 1913 to August 1945. Her reports to the Grand Parlor were heart rending and told wonderful stories of children sent to warm and loving homes. She did not neglect the business nature of the reports and gave comprehensive statistics as well. Beloved for her devotion to the work of the Homeless Children, she was made a permanent member of the Grand Parlor in 1938 on the twenty-fifth anniversary of her employment as Secretary.

In 1946, the State Department of Social Welfare issued a "Manual of Adoption and Procedures," which put increased pressures on the Committee, increasing the need for additional staff and more funding. The system that had fit the needs of the placement

of children for so many years was not geared for the post-war changes that occurred in the social welfare structure of the growing State.

In 1947, the Central Committee incorporated and became the Native Sons of the

Golden West and the Native Daughters of the Golden West Adoption Agency, Inc. The



name change signaled a more formal separation of the service from the general fraternal activities of the Orders and severed some of the very personal involvement felt by Members. In 1949, the increased demands of the State Department of Social Welfare became so great that it was voted to liquidate the agency. Offices in San Francisco and Los Angeles were closed in 1951 and funds were left in the corporation treasury until the last child placed reached the age of twenty-one. The funds were eventually divided between the Native Sons of the Golden West and the Native Daughters of the Golden West to be used for child welfare. The choice of the Native Sons was a charitable trust, which funds assistance to children through the Cleft Palate Fund. The Native Daughters of the Golden West chose to found the Childrens Foundation.

Statistics on the adoption agency: total number of children placed for adoption—7,714. My Mother, Dorothy Basher, was one of those children. Mom went on to join El Tejon Parlor No. 239, Bakersfield in 1964. When she passed away on March 20, 2011, she was a 47-year Member of our Order. She served her Parlor faithfully in many capacities throughout the years including Parlor President. Since Mom began her life with Native Daughters, we felt it was appropriate that she conclude her life with Native Daughters, so the Native Daughters Funeral Ceremony was conducted at her service by Joan Hall, PGP.

We have not been successful in tracing Mom's birth family, we do know, thanks to Native Daughters, that her birth mother was also a Native Californian. We have a series of letters from Mary Brusie, Secretary of the Central Committee on their letterhead, to my grandmother which clearly demonstrates the deep caring attitude of the NSGW and NDGW. They were making every effort possible to find the child that my grandmother so desperately wanted. There was a brief period where the birth mother was wavering in her decision to relinquish her child. Once she had made her final decision, my grand mother went to San Francisco to pick up the baby. She had been ill on and off, and the NSGW and NDGW agency indicated that if extensive medical care and hospitalization was needed, they would have the baby cared for in San Francisco and they would be able to cover all the costs so it would not be a burden to the adoptive family. Luckily, my grandmother found a wonderful doctor in Bakersfield who was able to improve her health. He remained the family doctor and actually delivered me when I was born.

I can only say that I thank my lucky stars for the NSGW and NDGW Adoption Agency for finding such a wonderful, loving, and caring family for my mother and subsequently for my mother's children, grandchildren, great-children, and great-great grandchildren.
