San Jose Parlor No. 81

The 2015-16 term has been and will be a busy year for San Jose Parlor No. 81.

Change of Meeting Location: After meeting for over 25 years at the same I.O.O.F. Hall in San Jose, for multiple reasons it became necessary that the Parlor leave this location. The Parlor decided that starting last August, both monthly meetings (1st and 3rd Thursdays) would be held in Members' homes, and to "mixit up" a little, occasionally some meetings would have different themes/activities or would be held in a restaurant. Mary Ann Scadina arranged for a daytime meeting in October at Harry's Hofbrau. In November, a Pajama Party was held in the home of PGPs Linda Galassi and Sharon Logan, and a "Shamrocks and Bunnies Night" theme is planned for the second meeting in March at the home of Robbie McGagin.

Name Badge Orders: For the 6th year, San Jose Parlor offered Native Daughters the opportunity to purchase a personalized California-shaped name badge. Fifty-nine badge orders were placed and mailed in October. Since 2010, a total of 252 badges have been bought and worn by our Sisters from all over the State. The Parlor hopes to continue this Extension of the Order project as long as there is significant interest.

Fantasy Tea Fundraiser: The Members of San Jose Parlor were invited to participate in a "Fantasy Tea." An invitation, a tea bag, and a return envelope were sent to each Parlor Member, requesting that during the hectic holiday season, they brew a cup of tea, put their feet up, and take time out to donate to their Parlor. This is a convenient way for those who are not able to attend meetings and/or participate in activities to support their Parlor. Many thanks to the Fantasy Tea donors!

Holiday Party: To celebrate the holidays, San Jose Parlor held a luncheon on December 9th at the Blue Pheasant Restaurant (on the Blackberry Golf Course) in Cupertino. The holiday-attired partygoers enjoyed a delicious lunch plus visiting and a Christmas trivia game.

Community Service: Some of San Jose Parlor's most rewarding activities revolve around serving the local South Bay community.

Baby Layette Project: Parlor Members continued their summertime contributions of new baby items and cash to the Baby Layette Project of the Diocese of San Jose. This annual activity, with a "Christmas in July" theme, supports the Diocese and Visiting Health Nurses who furnish clothing and other baby items to mothers who otherwise may not be able to provide the bare essentials for their newborns.

Heart of the Valley Services for Seniors: This is a new activity for San Jose Parlor. Heart of the Valley provides free services to seniors in the area, such as escorted transportation for shopping, errands and doctor appointments, help with pet care, minor gardening and handyman projects, filling out forms, writing letters, paying bills, and companionship/visitation. Instead of exchanging gifts at the Parlor's holiday party, it was decided to donate toiletries and personal items to Heart of the Valley's "Safety Net for Seniors" project for shut-ins. Then prior to Christmas, PGPs Linda Galassi and Sharon Logan joined other Heart of the Valley volunteers to deliver holiday gifts to the agency's clients. The Parlor plans to keep Members informed of future opportunities to provide volunteer time and goods/services to this very worthwhile organization.

JW House: Located adjacent to the Kaiser Hospital facility in Santa Clara, JW House (modeled after the Ronald McDonald Houses) provides a caring and compassionate "home away from home" for families facing medical crises. Families and individuals are welcomed for rest, meals and overnight accommodations while their loved one is in the hospital. One of the ways community organizations and businesses support JW House is by providing food for their "Dinner Is Served" program, and on January 14, San Jose Parlor cooked and served our popular Walking Taco buffet for approximately 30-35 people.

Evaluation of Proposed New NDGW Rituals, Ceremonies and Manual of Instruction: On January 19th, San Jose Parlor met to review and evaluate the proposed changes to these sections of the Books of the Order, which were distributed at the close of GPAM 2015. The Parlor's suggested modifications will be submitted to the Ritual and Manual of Instructions State Committee by the February 15th deadline for input.

Upcoming Activities:

District 20 Joint Official Visit: On Saturday, February 20th San Jose Parlor will join with hostess Vendome Parlor No. 100 and Gilroy Parlor No. 312 at the Official Visit of Grand President Bonnie Tabor for a "Stroll Down the Garden Path" luncheon at the Three Flames Restaurant in San Jose.

"Road Trip" to Historic Benicia: On Tuesday, March 22, Parlor Members will travel to Benicia, our early State Capitol. As with all such outings, the traveling group will have lunch— hopefully on the pier overlooking the Bay.

Bunco and Brunch Fundraiser: Another Parlor Bunco party is scheduled for Tuesday, April 12, at the home of Shirley Svindal. Players will gather this year for brunch and then continue with the traditional afternoon of playing Bunco with cash prizes for winners.

GPAM 2016: Based on past participation, San Jose Parlor anticipates that 10-12 Members will travel to Modesto in June for this year's Native Daughters of the Golden West Grand Parlor Annual Meeting. In addition to the Parlor delegate's participation in the business sessions, the entire group looks forward to the various luncheons and to renewing friendships and making new friends with Sisters from other Parlors. It's always a highly anticipated week for San Jose Parlor.

NSGW and NDGW Homeless Children Project: Out of the Archives

Each year NDGW Archives receives multiple requests for information about "The Children" who were adopted through an adoption agency run by the Native Sons and Native Daughters. Sadly, we have to say that we do not have information because when the State of California took over adoptions we were required to turn over all of our records.

Every once in a while, we discover a forgotten "treasure" which has been tucked away in a box or information comes in from a Parlor which has closed. As time permits, the Archive Committee will process and organize incoming records. We keep the minute books and discard items which have no historic value to our Order. Recently we came across a picture of a baby. It had the name "David" written on it. We had no idea why this picture would have been sent with the records of a closed Parlor. As we looked further, we soon discovered there were also receipts for milk for David. We consulted the

Red Centennial Book and the Proceedings of Past Grand Parlors and discovered that Parlors around the State temporarily named

a baby that they supported through milk. These receipts which recently surfaced were from 1932-34.

Further research in the Grizzly Bear, the publication before the California Herald and the California Star, showed the babies were most likely born in a hospital in Los Angeles or in San Francisco. There was a physician and a social worker in San Francisco who worked closely with our Orders.

The group homes which the babies lived in were known as "cottages." One cottage was known as Felton Cottage and the second was known as Holsclaw Cottage. These cottages were located at 740 and 745 30th Avenue. Our research does not show who owned these homes. Felton Cottage was named for Katherine Felton who worked for the Social Service Department in San Francisco. Miss Felton was secretary of the San Francisco Associated Charities who approached Pacific Parlor No. 10 of NSGW to ask for assistance in making plans to aid the Homeless Children of California. Holsclaw Cottage was named for Florence Holsclaw a physician at Children's Hospital in San Francisco. Both of these ladies were forerunners and on the cutting edge to see that the needs of women and children were met. In 1909, the Central Committee on Homeless Children was established. As the State of California government grew to meet the needs of the citizens, this Committee was licensed as an adoption agency.

> Uponchecking the 1940 Federal Census for San Francisco, there was a listing of an institution known as Babe's Aid Nursery on 30th Avenue. Mary Powell was the manager. There were seventeen infants from 0 to 2 months old and one four-monthold baby.

When the State of California took over management of adoptions in our State, the remaining funds were split between the Native Daughters and the Native Sons. The Native Daughters continues to work for children under the nonprofit NDGW Childrens Foundation.

Your donation is combined with Federal funds, used by the Forest Service to do the planting on the National Forest nearest you, or on the forest of your choice. The plantation will be marked with a standard Forest Service sign naming the contributing individual or organization. Contributions must be in multiples of \$68 or more. For each \$68 contribution, you will receive a PENNY PINES certificate from the Forest Supervisor, who will inform you of the location of the plantation at your request.

It is understood that each contribution of \$68.00, or multiple thereof, will be made payable to USDA—FOREST SERVICE and mailed to Penny Pine Coordinator, USDA Forest Service, 1323 Club Drive, Vallejo, California 94592. Such contribution is for deposit to a Cooperative Work Fund as authorized by the Act of June 30, 1914 (16 U.S.C. 498) and is to remain available until expended to assist in the reforestation of National Forest lands.

It is understood that no Member of or Delegate to Congress or Resident commissioner, shall be admitted to any share or part in this agreement, or to any benefit that may arise therefrom and that the accomplishment of the Forest Service's share of this agreement is contingent upon the appropriation of funds by Congress.

The agreement covers the initial and any subsequent contributions which may be made by the contributor during the period of this agreement. The period of this agreement shall be from the date shown until cancelled by written notice from one party to the other.

In turn, Mexico ceded nearly half of its territory, including what became the states of California, Arizona, New Mexico, Texas, and parts of Colorado, Nevada, and Utah. California officially became a state (the 31st) in 1850.
