## **Grand President Karen H. Fini: Installation Speech**

Thank you for this enormous honor of being installed as your Grand President for the ensuing year. I am not only honored but very humbled in accepting this awesome responsibility.

First, I must thank my family for putting up with me through this long process. Dan, thank you so much for your love and patience which are so appreciated. I love you. (GP Karen then introduced her family and friends in attendance.)

You will note a Bear Flag on my emblem this year. This is to honor my Great, Great, Grandfather Captain Jonathan Grigsby who brought one of the first wagon trains into

California in 1846, a year before the Donner Party, and was one of the 16 men who participated in the Bear Flag Revolt. My intent was to honor him and the pioneer mothers and fathers who have gone before us and who worked so

diligently to create this wonderful state we were so privileged to be born in.

You may say, "Oh, but that is not the original Bear Flag." But, it was the one created as the Grigsby Guidon when he commanded Company "E" in with John Fremont's men in their pursuit of a peaceable state in its early formation stages.

As many sages wiser than I have often said, "The only thing constant in life is change." Our beloved Order was formed in 1886 and as many of you have pointed out to me, that in the past 132 years, little has changed within out Order. Many of you have called me and expressed your frustration with our Order and its "out of date" workings.

Our membership is steadily decreasing.

Many of you have indicated that you will not serve the Order as a Board Member or Deputy, or in other capacities given the current state of the Order. It is increasingly difficult to find qualified candidates to serve in these offices. As many of you are aware, we are a volunteer organization. We are not paid, even as Officers for the work we do as Board Members, the lunches, or other events we attend. We pay for our nights at the Home, and our formals and dresses for the many events we attend. Many Members do not have the resources to dedicate to this endeavor for our beloved Order, and I fully understand that. Additionally, your Grand President must raise the money to pay for the Annual Meeting of the Order, which often exceeds the sum of \$25,000. We are not paid for what we do, although the Grand President receives a monthly stipend of \$600.00 per month and has received that amount since 1972. We often laugh that we are our own best charity.

You have asked me what we have to offer to today's woman who has so many demands on her time and budget, not only as a working mother, and as a homemaker, and where there is little extra in the household budget to afford our Order. No longer is her social life confined to cooking, cleaning, and rearing children, but working outside of the home, running her home, and often as a single parent with children, and ministering to their needs. You have asked for change, and I hope this year to implement some of the changes which you have asked for.

No one can do this job alone, and it is my intent to place people in positions where they can best serve the Order for the ensuing year. Just because you have had a committee to which you were previously assigned, does not mean that you will still have that position this year. It is hoped that these changes will implement some of the changes you, as Members, have asked for. I have given a great deal of thought to each of these committees, and what is in their best interest. Just because you have not received a request to serve on a committee or as a Deputy of Supervising Deputy does not mean you cannot serve the Order. There are many ways to do so, and I hope that you will.

In that regard, I have asked Past Grand President Sharon M. Johnston to serve as a liaison between the Past Grand Presidents and the Board of Directors, and she has graciously consented to accept this position. She will attend all Board meetings and serve as my liaison in that capacity. Thank you, Miss Johnston for your gracious generosity and service to our Board.

There will be a short meeting of the Past Grand Presidents at 8:00 AM sharp in the morning to answer any questions they may have.

The Deputy Grand Presidents and Supervising District Deputy Grand Presidents who have consented to serve this year will meet with metomorrow morning at 8:30 AM and will be introduced to the new liaison for the DGPs and SDDGPs. These selfless women will complete a form each month

and copy their liaison with it. That liaison will then meet with me and report on the condition of each Parlor monthly. I feel that it is in the best interest of the Order it we are aware of the condition of the Parlors at all times, and, if there are problems or issues with which we may assist the local Parlors, we may attempt to do so.

Following this meeting, your new Board of Directors will have a private breakfast at 9:45 AM, followed by a Board meeting. See, we do go right to work, and it is our intent to work hard for our beloved Order.

I thank each of you for your service to the Order in the past and look forward to the coming year and, with your help, we can effect the changes you have asked for and make this a better and stronger Order.

My door is always open and my phone is always on if you wish to talk. I have been told I can't do this, but all I can say is I will try my best. I expect to make some mistakes, not too big of ones I hope, and I hope you will be there to help me as I attempt to serve our Order. It is not about me, but about our Order.

You will find your individual and/or Parlor packets outside the door. Please take one with you as you leave tonight — there is information in there to assist you.

## **Exciting Updates from GPAM 2018**

Thank you to Jr. PGP Cynthia Connelly for all of her efforts in presenting an enjoyable Grand Parlor Annual Meeting in Sacramento. The GPAM 2018 Sessions Committee and the Hilton Arden West Staff worked diligently to ensure that everyone had a great week. All of the Sisters in attendance were thoughtful and well-informed on the proposed legislation as well.

At this year's Grand Parlor Annual Meeting, it was voted not to increase the per capita tax for the 2018-2019 term. The budget was passed with the annual per capita tax set at \$29.00 with \$14.50 paid by July 31, 2018 and \$14.50 paid by January 31, 2019. The audit form has been revised and is now posted on the N.D.G.W. website (www.ndgw.org)

Another change approved by the membership at Grand Parlor Annual Meeting was to modify the N.D.G.W. Application for Membership. The changes are in place for a two-year trial basis and it is everyone's hope to streamline the membership application process. These changes are designed to enable Subordinate Parlors to initiate new members in a more timely way. Your Recording Secretary will no longer need to send signed applications into the Grand

Parlor Office for approval. Instead, the document review process will take place at the Subordinate Parlor level and only the Activity Report and Membership Card will be sent into the Grand Parlor Office. It was also voted to approve the removal of past dues/fees owed for returning members. This change was implemented to allow returning Sisters to simply be "welcomed back" into Native Daughters.

Also, regarding meeting attendance, Parlor Members are allowed to attend a meeting by electronic media, phone, etc. and will be considered present and can participate in the meeting if they are in communication for the entire meeting. This procedure can also be used for the required quorum for a legal meeting.

Great thanks are extended to the 2017-18 State of the Order Committee under the guidance of Chairman PGP Debi Stalder; the State Chairman of Legislation, PGP Sharon Johnston and her Committee along with the Co-Chairmen of Extension of the Order PGP Beth Perrin and PGP Camelia Robles and their Committee for their hard work and dedication to the betterment of our Order.

### Report of the State of the Order 2017-2018

 $The State of the Order Committee \, met four \,$ times before Grand Parlor Annual Meeting. As a committee member of Personnel, the committee was very active this year with a transition of Personnel in the Grand Parlor Office and additional support employees at the NDGW Home.

It has been a very difficult year for Personnel with attaining Grand Parlor Office Staff! On behalf of the members of NDGW I would like to recognize, with great appreciation, the Order's long-term Bookkeeper, Francine Bremer for her valued service to our Order and wish her a wonderful retirement and heartfelt thank you for her most admirable employment to our Order.

The Committee met to prepare the Recommendations and Resolutions for submission to the voting members of the Grand Parlor Annual Meeting. A Personal Thank you to Suzi Riley, PGP, for taking the initiative to be our typist and prepare the Recommendations for printing and also preparing the Advanced Reports too! Her skills were invaluable!

As I mentioned in my report as State Chairman of State of the Order in 2013-2014, "The Parlors need to understand that the Order cannot sustain membership or growth if the voting members at the GPAM do not know what direction they want to go for the Order's future. If members do not speak up about "Change" we will fail! Don't just leave those decisions in the hands of the Grand Officers, PGP's, and State Committee's! Get involved!" I feel this statement is still valid and important to the future of our Order!

The other duties of the State of the Order include reporting on the, "State of our Order" to the Members! It is a very important task that the committee takes very seriously!

Membership is declining, Parlors are consolidating or surrendering their charters, and lack of Parlor meeting attendance is a problem. Ladies we need to have something to offer to attract people to get involved and then retain their membership! Yes, it can be hard at times but as our Worthy Grand President has stated all year, " How much do you value your membership!" It is a very important true statement!

The NDGW Budgets for the Administrative Committees are always a concern and of course per-capita and assessments to the Parlors are crucial and the impact on raising dues for Sisters' who are on a fixed income is always a sensitive issue. In the last five years the cost to conduct the business for the Grand Parlor Office has escalated substantially, especially employee salaries and services in the City of San Francisco! I strongly suggest that the Board of Directors appoint a non-biased special committee of Members to assess the problem of continuing to keep the Grand Parlor Office in the City of San Francisco which is one of the highest cost of living areas in the State of California or relocate the Office in another more economically feasible area of the State. This committee would report the findings to the 2019 delegates in Fresno, California for consideration.

The Committee is pleased to announce that the NDGW Home is becoming more and more self-sufficient with an increase in Guest Room use! Grants, Room Rents, Invested Funds, and Fundraisers should be the only income needed to maintain and operate the Home! The goal should be to be fully self-sufficient with zero Member assessment, hopeful in the near future! Our NDGW Home is one of our most valued assets and the State Committee and the Employees should be commended for their dedication and valued passion of our "Julia Morgan Lady."

Last year the Public Relations Committee offered tools to help attract new Members and we appreciate the Parlors that used these ideas and tools with success in increasing Members, but I am sad to say that some Parlors never even opened their Packet to use them! Good news! State of the Order is pleased to see members wearing their Official Red "Join Us!" T-Shirts and continue our campaign of "Join Us!"

Another topic that is so very important to the future progress of our Order is attracting qualified Members to seek the office of a Grand Officer and have the work ethic to find solutions to have our Order's succeed in the future! One problem with the lack of interest in seeking the desire of becoming the leadership of our Order is that Members are not prepared to serve our Order in Administrative Positions, State Committees, and the passion about knowing and abiding by the Books of our Order. Members should have something to offer to the leadership before they even consider running for Office! Sisters, we cannot wait for Grand Officers to be trained and groomed to be the leadership once they are on the Board! The reality is that you need to hit the ground running on day one of your first day of serving on the Board! Sisters, get involved and ask the Grand Vice President and Grand President for appointments to strengthen your knowledge and skills before seeking to become a Grand Officer! Also, the Past Grand Presidents are a very valuable

source for mentorship and advice! The cost of our Grand Parlor Annual Meeting is always a concern especially for the Grand Officers that seem to always be overwhelmed with the responsibility to the Host Districts and Parlor Sisters involved. We need to address this issue in several ways: Possibly appointing a State Grand Parlor Annual Meeting Site Committee that would thoroughly investigate several locations within the State and present the recommendation to the delegates for decision of where we will Host our GPAM! Another part of cost is the mandated things that are required to conduct our Annual business meeting. Who should be responsible for the cost? I am a supporter of having the Grand Parlor Budget take more financial responsibility to conduct our Annual Meeting and not have the majority of the financial burden placed on the Grand President and her Committee! The cost has become unreasonable to ask these Sisters to take on that burden! Another Committee needs to be appointed to evaluate the cost to conduct the Annual Meeting and then report to the Delegates with what is required, and the optional expenses that would be the Grand President's Sessions Committee's responsibility for personal optional expenses!

We the Sisters of this noble Order of the Native Daughters of the Golden West must take on the challenge of our declining membership, strong leadership and escalating cost as our primary goals or like I said in 2014! " Or Nothing else matters!"

I would like to "Thank" Grand President Cynthia Connelly for my appointment knowing we would not always agree with everything! To my very capable committee sPGP Dolores Ferenz, Hayward Parlor No. 122, PGP Christine Tripod, Hayward Parlor No. 122, PGP Suzi Riley, Bonita No. 10, Elza Paul, San Juan Bautista Parlor No. 179 and GT Susan Collins, Fort Bragg Parlor No. 210, you all made me look good!

And lastly, to you all of my Sisters. I thank you for your valuable input and attention to the details and decisions made during this Grand Parlor Annual Meeting.

On Sunday, June 3, 2018, seventy Members and guests from throughout California joined the 2019 Sessions Committee at the historic Forestiere Underground Gardens in Fresno, for a special fundraising tour. The tour was followed by a luncheon hosted by Parlor Members Jennifer Ward and Merrie Sue Olson.

Baldasare Forestiere, a Sicilian immigrant, created the Underground Gardens on land he purchased in Fresno, California in the early 1900's hoping to become a

citrus grower. When the land turned out to be unfarmable, he began a 40-plus year project of tunneling through the hardpan underneath the topsoil. He created rooms, patios, arches, and planters for citrus and grapes using only a pick, shovel, and wheelbarrow. The Underground Gardens are a California State Historic Landmark and listed on the National register of Historic Places.

This year the Roll of Honor Committee had the privilege of reviewing the nominations of two wonderful ladies who have done much for the State of California and/or the



The nominees both exemplify the words of our Motto: "...to preserve California's history and better the quality of life.


Connie Rogers was nominated by Gilroy Parlor No. 312. She was born in Vermont and eventually made Gilroy her home in 1966. While she was a full-time mom she became active in her com-

munity including time spent on the Planning Commission and was a member of the Gilroy City Council from 1993-1997.

In the late 1990's she became a board member and later President of the Gilroy Historical Society. Under Mrs. Rogers' guidance the Historical Society began to sponsor events and programs to educate the citizens of Gilroy about the importance of preserving the Historical buildings of Gilroy. In 2008 the

financial crisis forced the City of Gilroy to close the Historical Museum. Connie recruited thirty volunteers who began work in February 2009. The Gilroy Historical Society is still staffing the city-owned Museum with about 28 volunteers. Connie leads 9 different walking tours of the City on a monthly basis. In 2014, Connie was instrumental in recruiting more volunteers to clean up and preserve the Old St. Mary's Cemetery. They trimmed the trees, put a monument on John Gilroy's grave and a sign identifying the cemetery, improved the lighting surrounding the cemetery







## **Update on State Funding to Establish** a California Indian Heritage Center

GAYLE GLEIM, CHAIRMAN LEGISLATIVE MEASURES STATE COMMITTEE

In May 2018 a letter was mailed to all Parlors and an electronic version of the same letter was distributed in early June to N.D.G.W. members via the Internet describing a proposed budget appropriation by Governor Brown to establish a California Indian Heritage Center on 43 acres west of Sacramento at the confluence of the Sacramento and American Rivers. The letter encouraged Native Daughters to let their elected State Assembly and Senate representatives know of their personal views about this proposal.

On June 20 at our 2018 Grand Parlor Annual meeting, Leslie Hartzell, Ph.D., Cultural Resources Division Chief in the California State Parks Department of the Preservation Of ficer and Tribal Liaison, gave a multi-mediapresentation about the condition of the current State Indian Museum next to Sutter's

Fort in Sacramento (which was supported at its inception in 1940 with financial support from the N.D.GW.) and the purpose of the proposed new Indian Heritage Center. Her good news at the conclusion of her remarks was that the \$100 million budget appropriation to begin the project was APPROVED BY BOTH THE STATE ASSEMBLY AND THE STATE SENATE and was awaiting the Governor's signature (which he delivered on June 27th)!

Hopefully, our Order not only will continue to respect and honor the contributions of our native tribes to the development of our State, but also can be of assistance in the establishment of this larger, interpretive complex to preserve, protect, and celebrate the rich living cultures of California's indig-



# Native Daughters of the Golden West Facebook Guidelines



## Advice as We Look to the **Future of the N.D.G.W**

At the 2018 Grand Parlor Annual Meeting our investments advisor for the last ten+ years, Greg Alessandra (Alessandra & Associates, Rolling Hills Estates, CA), gave a brief overview of the current status of our N.D.G.W. invested funds. As he closed his fiscal comments, he said he was taking off his "financial advisor's hat" and continuing his remarks as a friend of the Native Daughters.

Greg began by comparing two companies: Sears, Roebuck & Co. and Amazon.com. They both started as innovative companies, Sears in 1892 and approximately 100 years later, Amazon (1994).

Late in the nineteenth century Sears' founder recognized that there were great numbers of Americans who did not have regular access to retail establishments to meet their needs, and he initiated a mailorder business that over the next 60 years evolved into the largest catalog company in America. To the original catalog of watches and jewelry, Sears enhanced it's products to include sewing machines, bicycles, sporting goods, toys, furniture, hardware, and even cars—nearly everything a household could desire. In the 1920's through the 1970's the company added urban department stores that eventually overshadowed the mail-order business. However, over the years, Sears lost its innovative ability to meet the needs of its customers and with sinking sales and profits has been on a steady decline since the 1990's.

Taking advantage of the projected growth of internet commerce, Amazon's founder began the company as an on-line bookstore, and within a short time videos, CDs, video games and electronics were added to the product line. Realizing that consumers were searching for a larger, more diverse selection of items, Amazon built on its initial success and added clothing, furniture, food, toys, and jewelry. By 2015 the company had become the largest internet retailer in the world. In 2017 Amazon expanded into "brick and mortar" retailing with the acquisition of Whole Foods grocery stores. Amazon continues to grow because of its cognizance of current trends in retail shopping and its utilization of high $tech \, advances \, that \, adapt \, to \, a \, changing \, world.$ 

Then Greg said:

"So...why am I telling this story? We don't own Sears in your portfolio, and Amazon is our largest stock holding, but that's not why. I'm telling you this because I have an enormous affection for your organization. I want to see it flourish and live on in perpetuity. I think the Native Daughters organization

can learn from Sears and from Amazon. Ask yourselves,

- Are you adapting to changes in the world today?
- Are you relevant and interesting to young women in California in 2018?
- What are you offering your members?
- Do you have and support strong, decisive, professional management?
- Has your pricing—think membership dues-kept up with the times? Are they competitive? Are they priced inline with the true total cost of running the organization? Have you compared your dues to Rotary, Kiwanis, National Charity League, etc., etc.?
- Is the organization being operated in a profitable way? Are you adding to reserves or drawing them down?
- Are you actively seeking guidance from experts and getting opinions from outside the organization that may diverge from opinions, which may be long held but stale?
- What is your generation of Native Daughters members doing to invest in and increase the enterprise value of the N.D.G.W.? Will future generations look to you all as a group that added to the value or as one that accepted decline?

"With 5 million dollars in the coffers, you may not realize that you face existential questions. But you do. If you are not running with a balanced budget or profit, growing membership roles, and making the goals and values of your organization inextricably linked to the lives of your members, then you may be failing. Slowly maybe, but still failing. Don't starve the organization of the resources necessary to keep it going; and, more importantly, adapt it for today and for future generations of California's women.

"It is my sincere hope that these comments are understood to be a challenge—a positive challenge—to all of you to go back to your local Parlors and to the head organization to shake things up, adapt to the present times, convince every member that it is worthwhile to invest in the Native Daughters organization, and to become known as the group that re-invigorated and reinvented the organization. I am confident that you all—and the women who lived in California in the early days — have the strength, courage and wisdom to make this happen. Be the Amazon.com of fraternal orders, not the Sears, Roebuck... OK?"


## Flag Day — Long May It Wave!
