Awards at GPAM

Veritas No. 75 of Merced made a sweep on awards at the Grand Parlor Annual Meeting in Modesto.

Two Image awards! One was the Double T Ag Museum of Stevinson, California with owners Tony and Carol Azevedo accepting. This is a scenic and very interesting agricultural museum full of old charm, located in the heart of the San Joaquin Valley. The museum houses old farming equipment, an 1887 steam engine, horse drawn buggies and wagons, and antique household items. Tony says to visit the web site, TheDoubleT.com to view much of their collection. The History Train provides a two-hour dinner train experience offering an evening of find dining and a chance to see how the steam locomotive changed agricultural history in the San Joaquin Valley. Diners can experience what it was like to travel by train over 100 years ago. The Double T Ag Museum will have an open house October 30, 2016, and has invited the Native Daughters and Sons to come check it out. There is so much to see it would

be an adventure worth the trip. He took an application from the Native Sons, so hopefully they will keep in contact with him.

The next Image Award was for the beautifully painted underpass on G Street and the Santa Fe Railroad. The scenes are of Yosemite, the Sierra mountains and the Merced Courthouse all wonderfully done. The G Street Underpass in Merced is the result of a tragic accident that occurred in 1931 when a school bus carrying 57 children home from school was struck by a train at the crossing on G Street. Seven children and the bus driver were killed in the accident. Since 1931, the residents of Merced have been trying to get an underpass constructed to improve safety and traffic flow. On December 3, 2011, seventy years after the tragedy, the G Street Underpass was reopened to traffic. The \$18 million underpass is the first in Merced. The City of Merced allocated \$200,000 for artwork to depict the many beauties and wonders of the area including Yosemite National Park. The Merced community was asked to get involved in the painting of the tiles to complete the artists' design. Members of Veritas Parlor No. 75, Merced, were proud to participate in the completion of the project.

After a wonderful lunch and playhouse production, GPAM continued with the Roll of Honor Award recipient, Sarah Lim, Executive Director of the Merced County Historical Museum.



The Rollof Honor Award honors extraordinary women who are ineligible to join NDGW because they were not born in California. Sarah was born in China and immigrated to the U.S. in 1990, obtaining her citizenship in 1995. Sarah received her college education in California schools, earning a BA in History from UC Berkeley and then an MA in History from Cal State Stanislaus. Sarah was hired as the Merced County Museum Director in 2002 and she continues to hold the position today.

During her tenure as Museum Director, Sarah has curated over 40 historical exhibits showcasing the Merced area and has been responsible for the preservation of the wonderful written history and memorabilia of the area. Sarah works with many non-profit organizations in the community including the Historical Society and NDGW. Sarah's connection to NDGW is strong. Several members of Veritas Parlor serve as docents at the Courthouse Museum where Sarah is the Director. Sarah has permitted the 123-year-old original Charter of Veritas Parlor and Emblem to be stored in a climate controlled environment at the Museum. She has provided numerous historic photos, newspaper articles about Native Daughter events over the years and provided information that

would not have been able to be found by members of Veritas Parlor without her assistance. A NDGW plaque is proudly displayed in front of the Museum. Sarah is indeed a credit to her community and California, and she is a welcome addition to the diverse heritage of California's history.

We thank the members of Veritas Parlor for their nomination of Sarah Lim for the NDGW 2016 Roll of Honor.

Many of Veritas Parlor's members were on hand to congratulate Sarah and she was equally excited to receive this honor from the Native Daughters.

Established in 1886, our Members have the distinct honor to belong to, and be the stewards of, one of the oldest woman's service organization in the State of California.

The second reason this term is historic relates to the Mission Bells that mark the El Camino Real. The story of marking the El Camino Real is a great introduction to who we are as an organization: dedicated to preserving the history of California. The first bell was placed 110 years ago to mark the path between the California Missions, with the goal of putting one bell every mile along the historic route. Between 1906 and 1913, 450 bells were erected along the El Camino Real with the Native Daughters of the Golden West leading the way as the major

Arcata Parlor No. 325 Visits Historic Battery Point Lighthouse at Crescent City

The first oil lamp was lit at Crescent City Light Station on December 10, 1856. Beginning in 1856 the beacon, focused by its fourth order Fresnel lens, guided freighters into the city's bustling harbor, then out again bearing loads of redwood bound for San Francisco.

The thick stone walls of the lighthouse, built for a mere \$15,000, still stand to this day



will little change from the station's earliest days. However, the station's luck was almost exhausted in the wake of five titanic tidal waves on March 27, 1964. The lighthouse keepers were stranded in the lighthouse. There was no damage to the island itself, but the trapped keepers watched in horror throughout the night as the waves wreaked havoc on the mainland and swirled around the base of the lighthouse.

Arcata Parlor just experienced all this marvelous history with a guided tour of this lighthouse and were able to make a contribution from the Native Daughters Lighthouse Preservation Fund in the amount of \$500.00. The Del Norte County Historical Society $received \,this\,donation\,and\,explained\,that\,the$ proceeds would be used for current, much needed, renovations, especially the roof, at the lighthouse.


