Fort Bragg Parlor No. 210 Honors Edie Ceccarelli

On the exciting occasion of her 115th birthday, Fort Bragg Parlor No. 210 joined the community in a wonderful celebration of Edie Ceccarelli, the oldest living person in the United States, by presenting her with an honorary membership in Native Daughters of the Golden West.

It was a very rainy Sunday when Sisters Edith Goble, Betty Carr, Linda Thornquist Stumpf, Marilyn LeRoy, Nettie Van Meter, and Jr. PGP Susan Collins braved the weather and drove to Willits to present Edie Ceccarelli with a certificate for honorary membership in Fort Bragg Parlor. They joined many of Edie's family members and community members from throughout Mendocino County, a drive-by Birthday Party was held in Edie's honor.

Born on Feb. 5, 1908, in Willits, California, Edie is now the oldest known living person in the United States and the third oldest person in the world. Delivered at home she was the first of seven children born to Italian immigrants Agostino and Maria Recagno. Her parents ran a store in Willits during her childhood. She earned 50 cents a day at her first job of picking potatoes. She graduated from Willits High School in 1927 and later married Elmer Keenan in 1933. The family moved to Santa Rosa and adopted a daughter. After Elmer died in 1984, Edie married Charles Ceccarelli in 1990.

At the age of 104, after her long-time dance partner died, she published an open letter in the paper looking for someone to waltz with her. She lived independently in



Willits until age 107.

When Edie was born in 1908 it was an exciting time in our country, the first-ever ball drop took place on New Year's Eve -- A 700-pound electric ball from the flag pole atop the New York Times building in Times Square, Admiral Robert Perry began his conquest of the North Pole, Henry Ford introduced his first Model T, and Wilbur Wright flew in an airplane for almost two and a half hours.

According to the New England Centenarian Study, about one in every 5,000 people living in the U.S. is a centenarian (aged 100) and about 85 percent of them are women. The study says that genetics play a huge role in longevity.

So here's to Edie Ceccarelli and all our Native Daughter Members who have blessed this earth and our Order for 80, 90, and even 100 years. Women can do anything even at 100 years of age. Congratulations, Edie and Fort Bragg Parlor!

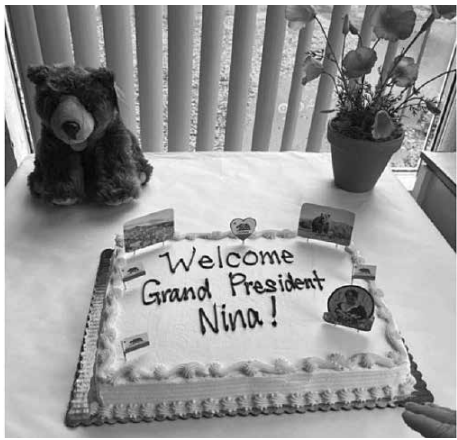

Besides participating in the Flags a Flying Photo Contest, below are three other suggestions for activities.

1. SupportOurTroops.org is a website which provides information on supporting deployed troops and their families. While there are several suggestions on how individuals and groups can get involved I would like to highlight Care Packages. Support Our Troops Care Packages enhance the morale and well-being of the deployed troops worldwide by seeking, receiving, and shipping care boxes containing items specifically requested by them. This is especially important outside the established holidays. The web site provides an extensive list of what items are requested and packaging rules. One of the most needed items are \$25 gift cards like VISA, Mastercard and American Express. The troops use these to get on the satellite for personal communications to home. Please read the instructions and other requests, too long to list here, on the website. DO NOT assume you know

what or how to do this! They also provide a list of NO-Nos. This project would make a great Parlor activity as you support our troops worldwide.

2. At the same website is another suggestion of CARDS and LETTERS. They provide writing tips to encourage our troops. You send the letters and cards to Support Our Troops (SOT) and they forward them. Again, please read the suggestions and what topics are to be avoided.

3. Providing a flag to a civic organization can also be a way your parlor can participate. Through a community liaison, find out if organizations in your community need a flag for meetings. Contact local scout troops, also, for flag replacement needs. Many times flag stands are needed and perhaps a parlor, who has access to wood-working members, could make one or more.



The NDGW Historic Landmarks and Buildings Committee is charged with collecting and recording historical data pertaining to our Order; assisting Parlors in marking historic buildings or sites; preserving the memory of the Pioneers; be alert to the destruction of buildings or sites having historic significance.

Any Parlor that wishes to place a new historic marker or monument is to consult with the Grand President and the State Chair of the Historic Landmarks and Buildings Committee. Before the Parlor places markers, the proposed wording and plans must be submitted to the State Chair for approval and verification before a casting is made of the plaque.

The Committee may authorize up to sum of \$350 per marker to help with the cost of the marker. Are there plaques or markers in your area that need repair or replacement? The Historic Landmarks and Buildings Committee would like to know. We want you and your Parlor to take pictures of the markers before they are gone. Submit a clear photo of the marker and a photo of the marker's location. The Committee looks forward to working with you and all Parlors.

Snowden was first established in the early 1890's by Bill Murray. In 1893 John Grant, Maxine Stanley's and the late Thelma Mills' Great Grandfather, purchased the property from James May. Grant died in 1895. His wife Emma built two barns, a saloon and a hotel to accommodate the mule trains traveling between Etna and the Salmon River mines. Snowden was also the exchange location for mail between Etna and the Salmon River Country. A Post Office was built in 1904 but moved to Sawyers Bar in 1913. Emma Grant continued to operate Snowden for many years. Later owners were Donald A. Parker, George Smith, Donald A. Parker, and Robert Young. The original buildings burned in 1935.
