Fort Bragg Parlor Receives Alder Thurman Award

On Sunday, November 2nd, NDGW Fort Bragg Parlor No. 210 was honored to receive the Alder Thurman Award from the Fort Bragg Mendocino Coast Historical Society. It was presented by MCHS President Mark Ruedrich to President Edith Goble at a brunch held in the North Coast Brewery's Sequoia Room.

The award is given each year to persons or organizations that promote the area's local history. Our parlor researches, applies for and places historical plaques recognizing local landmark buildings and historical sites. Most recently a plaque was placed in Otis Johnson Park honoring the city founders which was dedicated during our Walk with Paul Bunyan during the 2014 Paul Bunyan Days.

Other plaques that have been installed by the parlor are in the entry way of The Guest House Museum on Main Street which is housed in a historical building that was built by the Union Lumber Company in 1892. In 2012 the Parlor replaced a plaque at the Point Cabrillo Light House. It was originally placed by the parlor some years ago, but lost to theft.

We also have placed plaques on the bell of the First Baptist Church on Pine Street. This bell, the first in Fort Bragg, was built in England and came around the horn, it hung in the steeple and sounded fire alarms, and curfew, as well as summoning worshipers to church from 1890 to 1953. A plaque was placed at the

Grey Whale Inn which served as a hospital until the 1960's.

There are two pioneer graves in the Rose Memorial Cemetery. Each bears a plaque dedicated by NDGW Parlor No. 210. Sarah Foster (1826-1906) was a member of the Donner party and Britton Greenwood (1829-1888) was a member of the rescue party that helped rescue the survivors of the Donner party. These plaques were dedicated in 1995 and 1988, respectfully.

Toluca Parlor No. 279 Honors 75 Year Member

It is with great pleasure that Toluca Parlor No. 279, located in Burbank, California, honors their esteemed member Lucille Day Jacobson. Lucille was born in Los Angeles, California on October 10, 1915. She was initiated as a member of the Native Daughters of the Golden West to Verdugo Parlor No. 240 Glendale, California on March 11, 1938.

Lucille brought her secretarial knowledge to Toluca Parlor with the consolidation of these two Parlors in March of 2001. She continues to be as active as possible to this day.

At Toluca's meeting on November 11, 2014, it was unanimously passed that Lucille was to be our first permanent member. Parlor President Beverley Rios and PGP Adeline Coronado recently surprised Lucille with a spontaneous visit and presented her with our Parlor Certificate. Grand President Suzi Riley will be presenting Lucille with her 75 year pin in March of 2015 when District 26 has their Official Visit.


Have You Ever Thought of Serving on the Pioneer Roster & Archives Committee?

The Pioneer Roster and Archives Committee is a vital committee as we preserve the records of our beloved order. We meet every four to six weeks in San Francisco at our

Home on Baker Street. We would like to encourage a few more members to serve on our committee. We would like to be able to have our library opened on regular basis.

Did you know that we have Proceedings back to 1887 when the first Grand Parlor was held? The first Grand Parlor was held in San Francisco during the week of July 27, 1887. Just like our proceedings of today they tell what our sisters did in each session. The report of the finances committee was very interesting. They recommended that the Grand Secretary be paid ten dollars per month in acknowledgment of her services. They found it impracticable to form a correct estimate of probable expenses of Grand Parlor for the ensuing year. They were going to have a per capital tax of one dollar; fifty cents thereof payable in December 1887 and the remainder in July 1888. Traveling expenses of \$195.15 were paid out. The second session of Grand Parlor was going to be held in Stockton beginning on the second Tuesday



Our Pioneer Roster was begun in 1935. We have approximately 35,000 recorded pioneers. Was your ancestor in California by Dec. 31, 1869? Have you checked to see if your ancestor was recorded? If your ancestor was not registered, have you taken the time to enter him or her in our roster? To be entered in the roster one does not have to be born here, one just had to be present in our glorious state.

We have back issues of the *Grizzly Bear* and the *California Herald*. These were publications of our order before the *California Star*. San Francisco Public Library has put the complete run of the *California Star* on line.

I hope I have interested some of you to apply to be on the Pioneer Roster & Archives committee for next year. It is usually in January that the parlor secretary asks members to sign up to serve on the various committees of our order.

Saint Barbara made many public appearances before and during Fiesta, including the Misa del Presidente at Mission Santa Barbara, where she took part in the processional and recessional with the priests and sat in the front pew. Later she joined the large number of Native Daughters of the Golden West at the garden reception following the special Mass. Grand President Suzi Riley was an honored guest at these events, as were Dorothy Rogers, GT, Nickie Acevedo, GOS, and Joan Hall, PGP.

Renee Jackman Longo was born in Goleta and spent most of her life in the Santa Barbara area. She attended local schools and took part in a study abroad program at Cambridge University, England. She received her degree in art history from the University of California, Santa Barbara. Renee and her husband Dana have three children—India, Paloma, and Zane. She is a garden designer and is employed as event coordinator by the Santa Barbara Trust for Historic Preservation. A member of Reina del Mar Parlor for twelve years, Renee has assisted the parlor's History and Landmarks Committee with its many projects. Her mother Michele Jackman is a member of the parlor and her late aunt, Connie Williams, was also a member.

For her Fiesta public appearances at the Mission, the Presidio, and the Court House Mrs. Longo was dressed in the saint's traditional white gown and scarlet cape. She wore a golden

crown and carried the martyr's palm frond and a golden chalice. For the Mass and Fiesta parties she wore a long Spanish-style white lace dress and mantilla.

Other parlor activities this year have included assisting with a Fiesta exhibit at the Santa Barbara Historical Museum, selling items at a costume sale, volunteering at Stow House for July 4th, the local NSGW/NDGW Admission Day barbecue, a Halloween party, the annual Harvest Feast fundraiser (highly successful), and the joint Native Sons/Native Daughters Christmas dinner. 


Official Visit
