

Are you looking for a trip to the Coast fall thru spring? Sunshine, Trees, (see Cambria) Beaches, Sea Lions, Moderate traffic and plenty of History? The answer is Piedras Blancas Light Station, located ½ mile north of Hearst Castle. It is an important part of the history of San Simeon and the northern Central Coast of California. Built in 1875, it once served a crucial role warning mariner of the impending rocky cliffs, as well as helping them navigate their location off the craggy shores. Today, it is both a historic park and wildlife sanctuary that bears a powerful reminder of the

history of the area. Tours are conducted regularly and there is a small fee. Reservations: 877-444-6777, 15950 Cabrillo Hwy (1) San Simeon. Taking Hwy 5 or Hwy 101, exit Hwy 46 at Paso Robles you will avoid Hwy 1 and the winter landslides


Cambria has the lighthouse's First Order Fresnel Lens sitting in the center of town surrounded by a low fence, allowing visitors to casually walk around. Fund raising has been ongoing for some years to repair the Lens and in the past this Committee has donated to the restoration project

The List of interesting places continues to Santa Barbara.


Aleli Parlor No. 102 Welcomes Grand President Darleen Carpenter

November is National Scholarship Month. Are you aware that due to additional funding, the number and amounts available for scholarships and music grants have been increased? Do you know of a student with dreams of attending college or a vocational program? Do you know a young student who needs help acquiring a musical instrument or taking music lessons, or a school needing help in providing music education? NDGW Education and Scholarships Committee have the following scholarships and music grants available:

- Scholarships up to a maximum of \$2,000 each awarded to students enrolled at any University of California (UC) or any California State University (CSU) campus.
- A graduate scholarship up to a maximum of \$1,500 awarded to a graduate school student of a UC or CSU as a one-time gift.
- Annie L. Adair Scholarships up to a maximum of \$2,000 each awarded to students majoring in business or social welfare at an accredited California university or college.
- Sue J. Irwin Scholarships up to a maximum of \$2,000 each awarded to students of an accredited California university, college, vocational program, trade school, or online course.
- Bertha A. Briggs Veterans Scholarships up to a maximum of \$850 each awarded with the concurrence of the Veterans Welfare Committee to Veterans or their dependents, or active-duty military attending an accredited California university, college, vocational program, trade school, or online course. Recipients need not be Members of the Order or eligible to affiliate.

- Nursing Scholarships up to a maximum of \$1,000 each awarded to students enrolled in an accredited California nursing program. Recipients need not be Members of the Order or eligible to affiliate.
- Doris M. Gerrish Scholarships up to a maximum of \$2,000 each awarded to California-born women pursuing a teaching credential. Preference will be given to Members of the Order. Recipients will receive the scholarship for one year only.
- Sharon M. Johnston Music Grant up to a maximum of \$500 each awarded to students.
- Sharon M. Johnston Music Grant up to a maximum of \$500 awarded to a school.

This award can help dedicated and ambitious students achieve their goals and develop relationships that could result in new Members affiliating with our Order. Making a difference in the lives of California's children is the goal of our NDGW Childrens Foundation. If you're not familiar with the Childrens Foundation, it is

one of our 501c-3 non-profit entities within Native Daughters. Please check out the <u>Childrens</u> <u>Foundation page</u> on our website and its <u>Facebook</u> <u>page</u>.

Childrens Foundation provides grants to individual children – for needs such as hearing aids, physical and mental health therapy, speech therapy, orthodontia, and other medical needs or devices. It also provides Campership grants – to camps who provide experiences to children in California who might not otherwise get to attend summer camp. Among our grantees are camps that cater to children with diabetes, children who have an incarcerated parent, a sports camp that adjusts things so children with limited mobility can play, and children who are visually impaired. Our Childrens Foundation also awards grants to non-profit organizations who serve children in California.

Recently, members of the NDGW Childrens Foundation Committee took a tour of the facilities of the John Tracy Center (JTC) in Los Angeles.

One of their more successful programs is the Parent-Infant Program for families with babies and young children. This Parent-Infant Program identifies hearing loss at a very early age, and then begins specialized therapy so the child quickly learns how to navigate life despite their disability. This program also educates the rest of the family in resources and training so that the whole family can thrive.

JTC serves children who are hearing impaired. They know that early detection and intervention make a massive difference in the quality of life of a person who has the challenge of deafness or limited hearing.

This individualized service is costly, coming out to just under \$10,000 per year for one child. However, the impact is massive, resulting in a confident child

and healthier family. The NDGW Childrens Foundation Committee wanted to support this effort and chose to grant a sponsorship for 5 children.

This past March, members of the Childrens Foundation Committee gathered for a tour of the John Tracy Center and presented their staff with a check for \$48,100.
