Memorial Service for our Departed Sisters:

GP Darleen read the eulogy for our departed and memorial service began with a recording of Elvis Presley singing How Great Thou Art. Then the memorial for PGP Marie M. Otto, Grace Parlor No. 242, Fullerton was conducted by the PGPs of the order. The team of six entered dressed in gold robes and red stoles and the remainder of the PGPs entered dressed in white and assembled in front of the stage. Each PGP presented 3 carnations in red, white and yellow representing the colors of the Order in memory of both PGP Marie and her brother George. George always presented Marie with carnations each year she sought election to Grand Office.

PGP Marilyn Bustillos read the eulogy for PGP Marie.

EULOGY FOR PGP MARIE M. OTTO

Marie M. Otto was born in San Diego to Ernest F., native of San Diego, and Marie S. Otto, native of Wisselsheim, Germany, on November 7, 1940. Marie grew up in San Diego, attended San Diego High School and San Diego State College, graduating in 1962. She was employed at a law firm for 28 years and also participated in the family floral business during weekends and holidays. Influenced by her aunt, Myrtle, member of San Diego Parlor, and her father, member of San Diego Parlor No. 108, N.S.G.W., Marie joined Palomar Junior Unit No. 24. In 1957 she joined the senior Order, becoming a member of San Diego Parlor No. 208. For over 68 years, Marie was a faithful and ardent member of our Order. She progressed through the chairs in her home Parlor, serving as President during both the 50<sup>th</sup> and 75<sup>th</sup> Anniversary celebrations. In 1987, supported by her Native Son brothers, Fred and George, and by her Parlor, Marie was elected Grand Outside Sentinel. In 1991, she was elected to the office of Grand Marshal. On the evening of June 26, 1993, in Modesto, Marie was installed as Grand President of the Native Daughters of the Golden West.

The backdrop for the stage at her installation consisted of three panels with pictures of the California Tower at Balboa Park, the Cabrillo Lighthouse, and Mission San Diego de Alcala. Marie wore a black gown with a black and gold sequined bodice. She was escorted by her brother George. George and their cousins from Germany took part in a traditional family custom of mixing soil from California and Germany, representing the ancestry of the family. In her address, she announced her theme for the year "Reach Out for Native Daughters." She emphasized the need for new members and expressed her support for Veterans Welfare, Childrens Foundation, Education, and Mission Restoration. A tree lighting at the NDGW Home was announced for December 5, 1993. This popular tradition has continued annually and celebrated its 30<sup>th</sup> anniversary in 2023. She ended her address with the following poem:

We pledge ourselves to follow through the coming year The light which God give us;

The light of Truth, wherever it may lead;

The light of Freedom, revealing new opportunities for individual

development and social service;

The light of Faith, opening new visions of the better world to be;

The light of Love, daily binding brother to brother (sister to sister)

and man (woman) to God in ever closer bonds of friendship and affection.

Guided by this light We shall go forward to the work of another year

with steadfastness and confidence.

The 108<sup>th</sup> Annual Meeting of Grand Parlor, was held from June 22 to 24, 1994 at the U.S. Grant Hotel in San Diego, It was her pleasure to share her year with the 25-year Past Grand President, Hazel T. Mallette.

Marie continued to serve the Order faithfully as a member of various committees, secretary in her own parlor, attending events and meetings etc. She was cochair of the 2017 Grand Parlor annual meeting for Grand President Sherry Farley and she effectively represented San Diego Parlor No. 208 for many years. In 2018 Marie began her year as the Silver Anniversary Past Grand President, celebrating the event at the 2019 Grand Parlor. After San Diego Parlor consolidated into Grace Parlor No. 242, Marie continued her participation as health permitted. In her later years, ill health prevented her from traveling but she attended Grand Parlor via Zoom. Marie's smile, her infectious laugh, her good humor, and her faithfulness to our Order will be greatly missed. God speed, Marie. May you be happily reunited with your beloved family.

I am indebted to Historian, Mary Louise Days, for her report in the 2018-2019 proceedings on Marie's 25<sup>th</sup> Anniversary as Grand President from which information was gathered for this eulogy.
