

Parlor Happenings...



Prairie City Plaque

It was a foggy Saturday December 13, 2025 with the temperature around 41° when thirty sturdy individuals gathered to rededicate the historic Prairie City plaque located off Highway 50 near Folsom California.

Prairie City was a booming mining town founded in 1853. It's been reported that at its peak the town comprised of 100 buildings, including 15 stores and 10 boarding houses. As with many gold rush towns work for the locals depended on the common everyday needs of the miners. Buildings housed a drug store, a mercantile store, a saloon, Wells Fargo Express and others. Two stages lines ran daily between Sacramento and various sister mining towns.

Gold production peaked at just over \$81 million in 1852 and bottomed out at \$17 million in 1866. After the 1864 election, the Prairie City voters, once the second-largest election center in Sacramento County vanished. By 1876 the only building remaining was a school. There were also remnants of an old livery stable and one cabin

The original historical plaque was placed in 1950, California's centennial year, by the California Centennials Commission, Fern Parlor No. 123 NDGW and Granite Parlor No. 84 NSGW. The Department of Natural Resources designated the plaque as California Registered Historical Landmark No. 464. The plaque was reportedly stolen sometime in 2023.

Barbary Leary, a Folsom historical society member and recently elected Councilmember, contacted Native Daughters inquiring about the possibility of replacing the plaque. A group was formed and headed by Forrest Parlor No. 86 and donations were obtained from the committee of California History, Landmarks, and Historic Buildings (CFIC) NDGW, Past State Presidents Association No. 16 NDGW of Amador County, Save the Landmarks organization, Forrest Parlor No. 86 NDGW and Native Sons' Grand Parlor.

The Native Sons of the Golden West provided a meaningful dedication ceremony as only the Native Sons can. Following the program light refreshments were served at the Hampton Inn & Suites.
